AN ORDINANCE AMENDING AND/OR REPEALING CERTAIN SECTION OF THE LEBANON MUNICIPAL CODE RELATING TO CARNIVALS, PARADES, ANIMALS, PEDDLERS, SOLICITORS, AND SALE OF GOODS; AND DECLARING AN EMERGENCY

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

<u>Section 1</u>. Section 5.20.200 of the Lebanon Municipal Code is hereby amended to read as follows:

"5.20.200 Prohibited Sales

Hawking or selling goods on the public streets and sidewalks in the City is specifically prohibited. The following exceptions to this prohibition shall apply:

- a) The holder, or designate of the holder, of a parade license properly issued pursuant to Chapter 10.36 of the Lebanon Municipal Code, shall be permitted to engage in hawking or selling goods on the public streets and sidewalks during, and in the immediate vicinity of, the parade for which that license was issued.
- b) Other persons, firms or organizations may engage in hawking or selling goods on sidewalks only during, and in the immediate vicinity of, a properly licensed parade.
- c) "Sidewalk sales", or other displays or sales of merchandise, are also permitted when lawfully done in accordance with the provisions of Section 17.16.060 or 17.18.060 of the Lebanon Municipal Code."
- Section 2. Chapter 5.32 of the Lebanon Municipal Code is repealed.
- <u>Section 3</u>. Chapter 6.16 of the Lebanon Municipal Code is hereby amended to add a new Section 6.16.030 as follows:

"6.16.030 Temporary Use Or Display Of Animals

Notwithstanding any other provision of this Chapter, it shall be lawful to display horses or other animals on a temporary basis for purposes of offering rides on said animals or other similar purposes. A license shall be required, however, for such activity, and the activity shall be conducted, in accordance with the following conditions and restrictions:

- a) No person, firm or organization shall display animals pursuant to this Section for more than three (3) consecutive days or for more than seven (7) days in any calendar year.
- b) The application for a license under this Section must be filed with the office of the City Recorder on a form to be furnished by the City Recorder, with the same information as is required for the application of a peddlers and solicitors license pursuant to Chapter 5.20 of the Lebanon Municipal Code.
- c) The license fee shall be \$5.00 per day, payable in advance at the time of the application for the license. Provided, however, that no license fee shall be required if no fee is charged for viewing, riding or otherwise using the animals, and no license fee shall be charged in any event if the activity is being conducted by and for the sole benefit of a non-profit organization.
- d) The licensee shall cause the area upon which the activity is to be conducted to be cleaned of animal waste and other debris hourly at all times while the activity is being conducted.
- e) The activity described in this Section shall not be conducted in any manner such as to interfere with the normal flow of vehicular or pedestrian traffic, or in any other manner which endangers or might tend to endanger the health or safety of any individual or of the public.
- f) Before a license may be granted pursuant to this Chapter, the applicant must provide written consent to the activity from the owner of the real property upon which the activity will be conducted.
- g) The license may be summarily and immediately revoked by the City Recorder or his designate upon any of the grounds listed in Section 5.20.160 of the Lebanon Municipal Code or upon any violation of this Section.
- h) It shall be the duty of any police officer of the City to require any person, firm or organization seen conducting the activity described in this Section and who is not known by such officer to be duly licensed, to produce the license and to enforce the provisions of this Section against any person, firm or organization in violation of the same."

<u>Section 4</u>. Chapter 10.36 of the Lebanon Municipal Code is hereby amended to add a new Section 10.36.055 as follows:

"10.36.055 Prohibited Activities

It shall be unlawful for any person during or in connection with a parade to throw any material or object from the parade route to or for those viewing the parade."

Section 5. It is necessary for the health, safety, comfort and convenience of the people of the City of Lebanon that this Ordinance have immediate effect. Therefore, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect upon its passage and approval.
