ORDINANCE NO. 1997

THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Section 1. That a special election be held in the City of Lebanon, Linn County, Oregon on the 12th day of August, 1986, for the purpose of submitting a proposed two year tax levy in excess of the tax base.

Section 2. At the special election the following measure shall be submitted to the legal electors of the City of Lebanon for their approval or rejection:

TWO YEAR OPERATING LEVY

Question: Shall the City of Lebanon levy \$372,418.00 for two years outside the tax base for operating purposes beginning in 1986-87?

Statement: If this measure is approved, the total City general fund budget for police, fire and other City services will be less than for the current year. The total amount to be levied for two years, if this measure is approved, will be \$744,836.00.

Section 3. The City Recorder is directed to file this ballot title with the office of the Linn County Clerk in accordance with ORS 310.330.

Section 4. The polling places for said election in the City of Lebanon shall be those designated by the Linn County Clerk for special elections; the poll books adopted for Lebanon by the Linn County Clerk as the poll books for said election are hereby adopted as the poll

books for the special election; the Judges and Clerks of election appointed by the Linn County Clerk to serve in Lebanon at said election are hereby designated as the Judges and Clerks of and for the City special election.

Section 5. The election shall be conducted by mail, and ballots must be returned to the office of the Linn County Clerk, Linn County Courthouse, Albany, Oregon before 8:00 p.m. August 12, 1986.

Section 6. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
