

particularly described as follows:


Beginning at the most easterly northeast corner of Gronso's Second Addition to the City of Lebanon, Linn County, Oregon, which said point lies on the east line of Second Street and the westerly line of South Main Road, and running thence South 0°00'30" East 159.15 feet; thence North 89°48'30" West 60.00 feet to a point on the west line of Second Street and the north line of Kees Street; thence North 0°00'30" West 258.2 feet returning to said westerly line of South Main Road; thence southeasterly along said westerly line, following a 432.1 foot radius curve to the left the chord of which bears South 31°-06' East 116.16 feet, to the point of beginning; SAVE AND EXCEPT a 15 foot wide easement along the east line of said property for the purpose of construction and maintenance of aerial and subsurface utility transmission lines. Said easement shall accrue to the City of Lebanon and to private utilities franchised to operate in the City of Lebanon.
