THE CITY OF LEBANON ORDAINS AS FOLLOWS

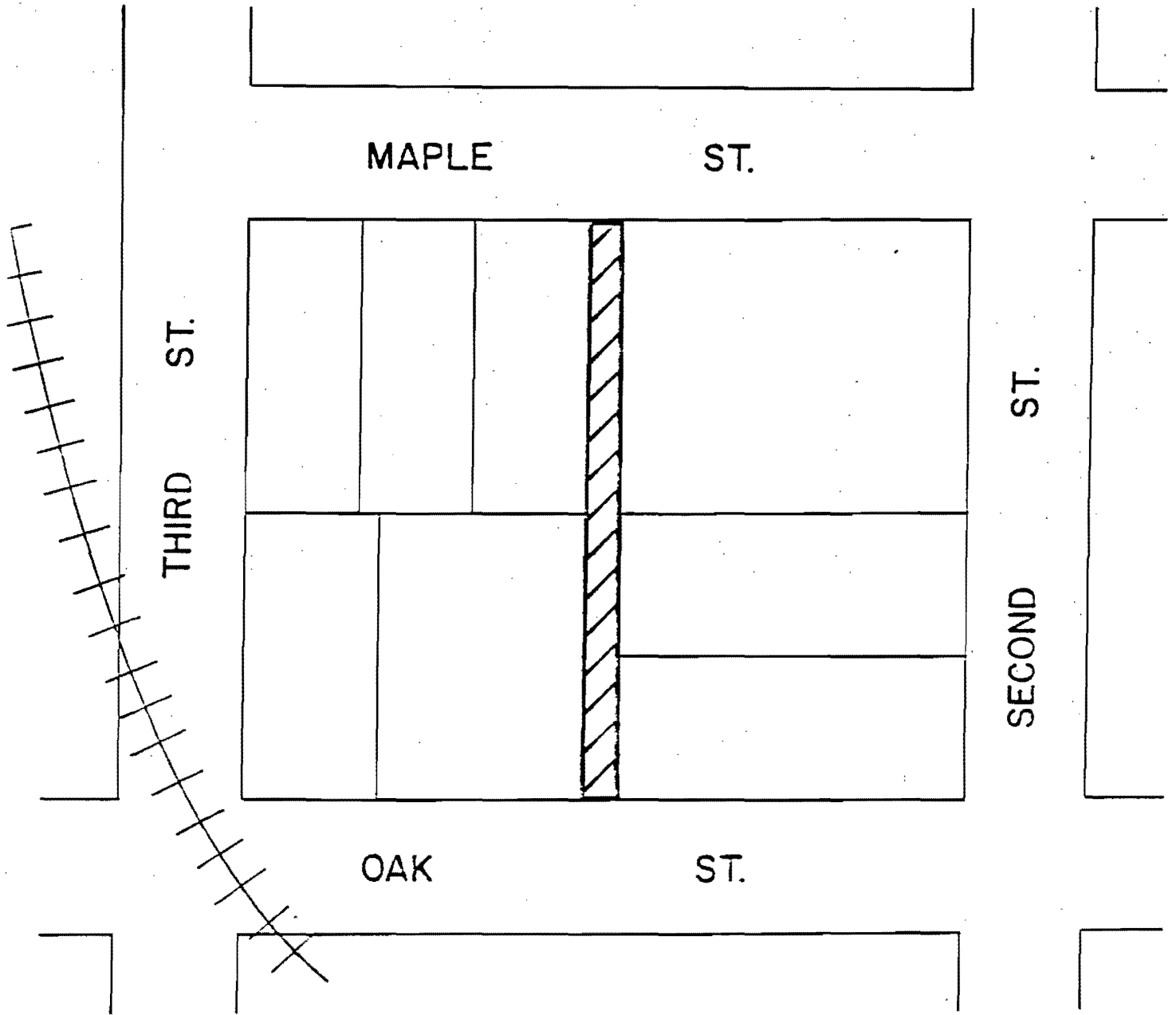
Section 1. That the following right-of-way, to-wit:

An alley running from Maple Street to Oak Street, between Third and Second Street, more particularly described as follows:

Beginning at the Southwest corner of Lot 4, Block 10, City of Lebanon, Linn County, Oregon, said point lies on the North boundary of Oak Street; thence West 12 feet along said boundary of Oak Street to the Southeast corner of Lot 8, Block 10 of the above mentioned plat; thence North leaving the North boundary of Oak Street along the East boundaries of Lots 5, 6, 7 and 8 to the Northeast corner of Lot 5, Block 10 of the City of Lebanon, said point lying on the South boundary of Maple Street; thence East 12 feet along said boundary of Oak Street to the Northwest corner of Lot 1, Block 10 of the above mentioned plat; thence South leaving the South boundary of Maple Street along the West boundaries of Lots 1, 2, 3 and 4 to the point of beginning; SAVE AND EXCEPT an easement in the alley to be vacated for the maintenance, repair, and or replacement of the existing sewer line. Said easement shall accrue to the City of Lebanon.

Section 2. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
