THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Section 1. Pursuant to Lebanon Municipal Code Chapter 8.24 Section 8.24.070, a public hearing was held as to the reasonableness of the attached Statement of Costs for mowing and weed abatement charges incurred by the City of Lebanon in 1987 and said Costs were found to be reasonable and do hereby become an obligation owed to the City by the owner of said property listed on the Statement of Costs attached hereto and made a part hereof.

Section 2. Emergency Clause. It is necessary for the health, safety, comfort and convenience of the people of the City of Lebanon that this Ordinance have immediate effect. Therefore an emergency is hereby declared to exist and this Ordinance shall be in full force and effect upon its passage and approval.
