

A BILL FOR AN ORDINANCE ACCEPTING) ORDINANCE BILL NO. 11
THE TRANSFER OF JURISDICTION OF) For 1991
CERTAIN COUNTY ROADS TO THE CITY OF)
LEBANON; AND DECLARING AN EMERGENCY) ORDINANCE NO. 2103

WHEREAS, the Board of County Commissioners for Linn County, having considered Resolutions #23 and #37 for 1990 by the City of Lebanon requesting transfer of jurisdiction over certain roads heretofore under the jurisdiction of the County governing body, said County roads and bridges described in Exhibit "A", incorporated herein by reference, and a portion of County Road No. 784B, located on 5th Street north of Walker Road, approximately 400 feet; and

WHEREAS, the Board of County Commissioners for Linn County, having issued an Order on the 7th day of August, 1991, offering to surrender jurisdiction of those roads and bridges described in Exhibit "A" and said portion of County Road No. 784B to the City of Lebanon; and

WHEREAS, the County having agreed to pay to the City of Lebanon a total of \$1,852,809, which includes \$50,000 intended as a reserve account for the bridges described in Exhibit "A" and said portion of County Road No. 784B; and

WHEREAS, the City of Lebanon has determined that the acceptance of the jurisdiction of such roads and bridges described in Exhibit "A" and said portion of County Road No. 784B is in the best interests of the citizens of the City of Lebanon;

NOW, THEREFORE, be it ordained by the people of the City of Lebanon as follows:

Section 1. The City Council for the City of Lebanon finds that the acceptance of the jurisdiction of those roads and bridges described in Exhibit "A" attached hereto and said portion of County

Road No. 784B is in the best interests of the citizens of the City of Lebanon.

Section 2. Pursuant to ORS 373.270(5)(b), the City Council of the City of Lebanon does hereby accept the Order issued by the Board of County Commissioners for Linn County on the 7th day of August, 1991.

Section 3. The City of Lebanon does also accept, pursuant to the County Order, the sum of \$1,852,809, which includes \$50,000 intended to be a reserve account for the bridges described in Exhibit "A" and said portion of County Road No. 784B, all of which funds are to be expended as authorized by ORS 368.722 and 373.260.

Section 4. The City Recorder of the City of Lebanon is further ordered to transmit a certified copy of this Ordinance to the Board of County Commissioners for Linn County.


Section 5. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health, and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
