

A BILL FOR AN ORDINANCE AMENDING ) ORDINANCE BILL NO. 13  
SECTIONS 17.08.040, 17.10.040, AND ) For 1993  
17.12.040 OF THE LEBANON MUNICIPAL )  
CODE, USES PERMITTED IN ACCORDANCE ) ORDINANCE NO. 2137  
WITH ADMINISTRATIVE REVIEW )  
PROCEDURES, AND DECLARING AN )  
EMERGENCY )

WHEREAS, on May 19, 1993, the Lebanon Planning Commission held a public hearing on a proposed amendment to the Lebanon Municipal Code, Sections 17.08.040, 17.10.040, and 17.12.040, pursuant to the provisions of the Lebanon Municipal Code, Section 17.58.040; and

WHEREAS, pursuant to Lebanon Municipal Code, Section 17.58.050, the Planning Commission has recommended to the City Council the approval of proposed zone text amendments which would affect uses permitted in accordance with administrative review procedures for accessory dwellings, zone text amendment 93-1; and

WHEREAS, pursuant to the provisions of the Lebanon Municipal Code, Section 17.58.060, the City Council has received the recommendation of the Planning Commission and has thereafter held a public hearing on the proposed amendment in conformity with the notice provisions of Chapter 17.66 of the Lebanon Municipal Code; and

WHEREAS, the City Council has considered the recommendation of the Planning Commission and the testimony of witnesses at a public hearing conducted on the 28th day of July, 1993; and

WHEREAS, the City Council has determined that it is in the best interests of the people of the City of Lebanon to amend Sections 17.08.040, 17.10.040, and 17.12.040 of the Lebanon Municipal Code, regarding uses permitted in accordance with administrative procedures;

NOW, THEREFORE, the people of the City of Lebanon do ordain as follows:

**Section 1.** There is hereby added to Section 17.08.040 of the Lebanon Municipal Code a new subsection (d) which shall read as follows: (d) Accessory Dwelling.

**Section 2.** There is hereby added to Section 17.10.040 of the Lebanon Municipal Code a new subsection (d) which shall read as follows: (d) Accessory Dwelling.


**Section 3.** There is hereby added to Section 17.12.040 of the Lebanon Municipal Code a new subsection (d) which shall read as follows: (d) Accessory Dwelling.

**Section 4.** Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health, and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.

Passed by the Council of the City of Lebanon by a vote of 5 for and 0 against, and approved by the Mayor this 28 day of July, 1993.
