WHEREAS, the City Council finds that the City of Lebanon contains within its boundaries several municipal parks, recreation areas, and other public open space; and

WHEREAS, the City Council further finds that the use of alcohol in neighborhood parks is detrimental to the maintenance of said parks without appropriate regulation and control;

NOW, THEREFORE, the people of the City of Lebanon do hereby ordain as follows:

## Section 1

There is hereby created a new section in the Lebanon Municipal Code, Section 12.12.015, Definitions, which is hereby enacted to read as follows:

The following definitions shall apply for the purposes of this chapter:

- (A) "alcoholic beverage" is any beverage having an alcoholic content of more than one-half of one percent by volume.
- (B) "neighborhood park" is hereby defined to mean the following municipal parks located within the Lebanon corporate limits: Ralston Park, Century Park, Weldwood Park, Christopher Columbus Park, Jaycee Park, Booth Park, and Had Irvine Park; but such definition shall not include River Park.

## Section 2

There is hereby created a new section in the Lebanon Municipal Code, Section 12.12.022, Alcoholic Beverages-Prohibition in Neighborhood Parks, which shall read as follows:

It is unlawful for any person to possess an alcoholic beverage in a neighborhood park without a special permit.

## Section 3

There is hereby created a new section in the Lebanon Municipal Code, Section 12.12.024, Alcoholic Beverage-Special Permit-Issuance Authority, which shall read as follows:

Notwithstanding prohibition against the use or possession of alcoholic beverages in neighborhood parks set forth in other ordinances of the City, the Chief of Police shall have the right to issue a special permit for the use and possession of alcoholic beverages in said neighborhood parks.

# Section 4

There is hereby created a new section in the Lebanon Municipal Code, Section 12.12.026, Alcoholic Beverages-Special Permit-Fees, which shall read as follows:

Any person or organization may request a permit referred to in Section 12.12.024, subject to the following conditions:

- (A) Payment of a fee in the amount of \$25;
- (B) The name and address of the applicant and other information as required by the Chief of Police shall be furnished prior to the issuance of a special permit.

## Section 5

There is hereby created a new section in the Lebanon Municipal Code, Section 12.12.028, Alcoholic Beverages-Special Permit-Conditions, which shall read as follows:

The granting of a permit referred to in Section 12.12.024, shall be discretionary with the Chief of Police and, if issued, such conditions may be attached thereto as will be in the best interest of peace, health and safety to all citizens.

# Section 6

Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health, and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
