ORDINANCE NO. 2216

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF LEBANON:

**Section 1.** Section 10.44.100 of the Lebanon Municipal Code concerning the prohibition of the riding of bicycles, skateboards, rollerskates and rollerblades upon certain sidewalks within the City limits is amended to read as follows:

**10.44.100 Sidewalk riding prohibited where.**

A. No person, other than a police officer or police reserve officer in the furtherance of his or her duty, shall ride or operate a bicycle or skateboard, rollerstates or rollerblades, upon a sidewalk in that area bounded by:


1. The north line of Vine Street from Park Street to Second Street;
2. *Both sides of Main Street from Vine Street north to Rose Street;*
3. The west line of Second Street from Vine Street to Oak Street;
4. The south line of Oak Street from Second Street to Main;
5. The west line of Main Street from Oak Street To "A" Street;
6. The east line of Main Street from "A" Street to Oak;
7. The south line of Oak Street from Main Street to Park; and
8. The east line of Park Street from Oak Street to Vine.

B. No person, other than a police officer or police reserve officer in the furtherance of his or her duty, shall ride or operate a bicycle or skateboard, rollerstates or rollerblades, upon sidewalks located within the following shopping centers open to the public:


1. Lebanon Plaza;
2. Safeway.

**Section 2. Emergency.** Because the elimination of conflicting uses between bicycles, skateboards, rollerskates and rollerblades and the use by pedestrians of sidewalks in commercial areas of the city is necessary for the peace, health, and safety of the people of the city of Lebanon, an emergency is declared to exist, and this ordinance is effective upon its passage by the council.

Passed by the City Council by a vote of 6 for and 0 against and approved by the Mayor this 10th day of December, 1997.
