

A BILL FOR AN ORDINANCE AMENDING LEBANON) ORDINANCE BILL NO. 3
MUNICIPAL CODE, SECTION 5.36 FOR PUBLIC) For 2002
DANCES AND DECLARING AN EMERGENCY) ORDINANCE NO. 2290

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF LEBANON:

Section 1. Section 5.36 of the Lebanon Municipal Code is amended to read as follows:

5.36.010 - Definition. Public Exhibition/Event means any activity where the public is permitted, or invited, to attend and where a fee is charged, or a voluntary contribution is paid, or solicited, for the privilege of attending; or any money is raised or items sold to defray the expenses of such exhibitions or events, unless exempted under Section 5.36.040 of this ordinance.

5.36.020 License Required – Fee. No person may conduct a public exhibition/event without first obtaining a license at a fee to be established by city council resolution.

5. 36.030 License–Application–Investigation–Denial.

- (1) An applicant for a Public Exhibition/Event license shall provide to the city administrator or his designate the following information:
 - A. The name and residence of the applicant or, if the applicant is a corporation, association or firm, the names and residences of the officers or directors thereof;
 - B. The particular location for which the license is desired, at which the Public Exhibition/Event is to be held;
 - C. The date or dates of all Public Exhibition/Events to be held under the license.

- (2) The chief of police shall cause an investigation to be made to determine whether the applicant or the activity meet the requirements of this ordinance. The license may be denied if the applicant or persons principally involved in the activity:
 - A. Are under eighteen years of age;
 - B. Have been convicted of a crime or violation of any city ordinance or state statute involving any of the following: assault, disorderly conduct, fraud, illegal gambling, narcotics, sex violations, civil disorder or liquor law violations;
 - C. Have presented any false or misleading information in relation to the application for the license.

(3) Persons "principally involved in the activity", as that term is used herein include, but are not limited to the following:

- A. Ticket takers
- B. Musicians
- C. Vendors at the event
- D. Bouncers
- E. Entertainers
- F. Managers, owners and producers.


5.36.040 Exceptions. Exhibitions/Events held by school officials, church authorities municipal corporations, nonprofit organizations, or those occasional events held in residential premises, are not required to be licensed under the provisions of this chapter; however, such exhibitions/events are subject to the provision of Sections 5.36.050 & 5.36.060 of this ordinance.

5.36.050 Inspection. All public exhibitions/events shall be open for inspection by any police officer of the city during the continuance of the exhibitions/events.

5.36.060. Violation. Violation of the provisions of this ordinance shall constitute a misdemeanor.


