WHEREAS, LMC 9.18 establishes the Lebanon Alcohol Impact Enhanced Enforcement Area; and

**WHEREAS**, the City Council has heard the report of the Lebanon City Attorney and the Lebanon Police Chief and comments from staff; and

WHEREAS, the City Council hereby finds that the Alcohol Impact Enhanced Enforcement Area should be expanded to include the area generally referred to as the Lebanon Plaza, and more specifically identified below; The Lebanon Police Department has, for years, received complaints of certain intoxicated or otherwise obstreperous individuals behaving repeatedly in a hazardous, offensive, or criminal manner in the Lebanon Plaza area; and

WHEREAS, the City Council finds that the Alcohol Impact Enhanced Enforcement Area has been useful and effective in dealing with crime in the downtown area and that it is important to the public safety and welfare of the City of Lebanon that the AIEEA be expanded to the Lebanon Plaza area.

## NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON ORDAIN AS FOLLOWS:

<u>Section 1.</u> Lebanon Municipal Code Section 9.18.035, Downtown alcohol and impact enhanced enforcement area – Established, is hereby amended to read as follows:

- A. A downtown alcohol and impact enhanced enforcement area is established.
- B. The boundaries of the downtown enhanced enforcement area shall be Vine Street on the North. Maple Street on the South, Park Street on the East and 2nd Street on the West; the boundaries shall also include that area commonly referred to as the "Lebanon Plaza" and consistent with the map attached as Exhibit A.

<u>Section 2.</u> Because the issuing and service of notices of exclusion from the AIEEA within the city is necessary for the peace, health and safety of the people of the city of Lebanon, an emergency is declared to exist, and this ordinance is effective upon its passage by the City Council.


