 Marshal present. Minutes of last  
 regular and adjourned meeting read  
 & approved, Councilman Burkhart  
 one of the committees on roads and  
 streets, appointed to construct side walk  
 to cemetery submitted verbal report that  
 the same had been constructed, the same  
 was approved, Chairman of Ordinance Com.  
 reported back Ordinance bill. No relating  
 to Grand District, appointments & duties of  
 road and street Supervisor and the levy  
 and collection of road tax, with recommen-  
 dation that it pass On motion further  
 action on said bill was postponed till  
 next regular meeting, Bill of Joseph  
 Meyer, for Lumber, Nails and <sup>amount \$40.75</sup> ~~mark~~ on  
 building sidewalk to cemetery presented  
 & read. On motion the same was allowed  
 and a warrant ordered drawn on the Treasury  
 for the same, Bill of Burkhart & Bilgen for  
 hauling lumber for Cemetery, \$ 3.00 presented  
 & read. On motion the same was allowed  
 and ~~an~~ warrant ordered drawn on the Treasury  
 for the same, Bill of Lebanon Engine Co  
 No. 1 for expenses and repairs of Hays &  
 Engine. Amount \$ 8.65 presented & read  
 On motion the same was allowed

and a Warrant Order drawn on  
 the Treasurer in favor of W. C. Peterson  
 for the same. No further business on  
 motion the Council adjourned

Council met in regular session, called to order  
 by the President. Roll call. Members present C. H. Kalds  
 President, Councilmen H. H. Rosco, J. W. Bushhart, E. E.  
 Montague and Joseph Elkins. Marshal & Recorder present  
 Minutes of last meeting read and approved. President  
 and Recorder submitted a report of the canvass of  
 the votes at the recent city election in which  
 it was found that W. B. Donaca had been elected  
 President of the Council and Jacob Bilyer, G. W.  
 Smith, E. E. Montague and Alex. Parrish Councilmen  
 G. W. Cruson Recorder, George W. Rice Marshal and  
 H. C. Harkness Treasurer. On motion the report  
 was adopted and the Recorder instructed to issue  
 certificates of election to the parties named  
 as officers of the Town of Lebanon  
 On motion the Council  
 adjourned.
