 on call of roll the following members were present
 G W Leruson President, F H Rosco, H C Harkness
 B H Donica Joseph Elkins councilmen,
 Recorder M S Roberts, Marshal F H Miller
 minutes of previous meeting read & approved
 on motion of F H Rosco that the marshal be ins-
 tructed to notify the first or second assistant
 foreman of the fire company to straighten up
 the apparatus carried & the marshal was so ins-
 tructed, on motion it was carried that the cou-
 ncil rent their hall to the grand army for one
 dollar per month carried & it was so ordered
 on motion that the Recorder be instructed to have
 the town hall insured for two hundred and
 fifty dollars \$250. carried & it was so ordered
 bill of F H Miller for one dollar & fifty cents
~~for~~ for arresting Hemillan presented &
 read & ~~allowed~~ on motion was allowed
 and a warrant was drawn for the same
 no further business on motion the council

 seal presented & read & on motion the same was
 allowed & a warrant was drawn for the same
 bill of G W Cruson for twelve dollars & sixty
 cents was presented & read & on motion the
 same was allowed & a warrant was drawn for
 the same, bill of N S Roberts for one dollar
 to pay for recording Deed was presented ^{on motion was} allowed
