Council met in a Special Call meeting Mayor V. S. Stewart being absent - J. R. Underwood was Elected Chairman of the meeting. Roll call showed all the Councilmen present except Councilman W. C. McClain. Communication for County Clerk M. J. Marks was read showing the valuation of property within the city of Lebanon as assessed on the 1912 tax roll to be \$39,180.00

Resolution No 13,

Fixing the tax levy of the city of Lebanon Linn County Oregon
For the year 1913

Indorsed by the Committee of ways and means where as it is necessary that money be raised by general taxation for the general expenses of the city of Lebanon Linn County Oregon and to pay interest in the bonded indebtedness of the said city and for the improvement and repair of streets and crosswalks and for the paving of the streets intersections of the said city in the paving districts, and for the salary of officers of the said city and other necessary expenses of the said city for the year 1913, and to pay the unbordered indebtedness of the said city now therefore be it Resolved that the Common Council of the said city of Lebanon, Linn County, Oregon in and at a Special meeting of the said Council duly called and held in the Council Chambers on the 17th day of Dec 1912 does hereby and by this resolution does make and fix the tax levy of 8 and 1/2 mills on the one dollar for general purposes and sewer bond fund interest of the said city and 1 and 1/2 Mills on the one dollar for roads and streets and crosswalks purposes in the said city upon the valuation of all taxable property in the said city on the valuation as given, shown and contained by and in the County assessment roll of Linn County Oregon for the said city for the year 1912 now on file and of record with the Clerk of and for said Linn County, Oregon, the said levy being made for the year 1913 for said city, and be it further resolved by the Council that the City Recorder of the city of Lebanon, Oregon,

Transmit immediately to the Clerk of Linn County, Oregon
in writing due and legal notice of this levy
Passed by the Council this 17th day of December 1912
