CITY COUNCIL CHAMBER,

Lebanon, Oregon, September 1st, 1914.

Council met in regular session, being called to order by Councilman Amos, as Mayor pro tem. *In the absence of the Recorder Councilman Blackburn acted as Recorder pro tem.*

Roll call showed all members of the Council present.

Minutes of the meeting of August 18th read and approved.

R#20 Report of Committee to draft resolutions on the death of Mayor Ziesing read and approved, and ordered spread upon the minutes, as follows:-

Reminded as we are of the uncertainty of life and the certainty of death by the death of Mayor Ziesing who passed from this life August 13, 1914,

Realizing that death comes to all, that life is but a span, that mankind at best is frail, and above all recognizing the great strength, power and love which come from Almighty God, and bowing to his Omnipotent Will,

We the members of the Common Council and Officers of the City of Lebanon, Oregon, wish to extend to the family and relatives, our sincere and heartfelt sympathies.

Silently as the sunshine leaves the hills, they are passing away, our treasured loved ones, from our homes, from our business circles and from our hearts; this time it was a loving husband, an obedient servant of the people, an energetic business man, who heard the chiming of the Golden Bells across the Misty Sea and fearlessly entered the Phantom Bark.

Resolved that these resolutions be spread upon

the minutes of the Council, a copy be furnished the bereaved wife and son, and a copy sent to each of the City papers for publication.

Mesars. Raugh and Cormier, as members of a committee appointed to report on the condition of the river bridge East of town, and also City Engineer McArthur, reported that the bridge is in bad condition owing to decay of the timbers, and advised that the matter be at once taken up with the County Court. The report was approved by the Council, and, on motion, the committee, consisting of S. P. Raugh, D. Cormier, A. W. Blackburn, J. F. McArthur, and J. E. Green, was made permanent, and the names of M. A. Miller and S. M. Carland added thereto.

The bill of E. L. Keebler for construction of curbing on Grant St. between the W. curb line of Park St. and the Eastern City Limits, under his contract, amounting to \$496.23, was on motion allowed and ordered paid.

The City Engineer presented the following estimate of work done to date by G. T. Morgan on his contract for improvement of Grant Street between Park St. and East City Limits:

On motion, the estimate was allowed, and warrant ordered drawn for \$764.23 in payment of same.

Mr. M. A. Miller addressed the Council in the matter of grading the alley just East of Main St., between Grant & Maple Sts., stating that he and other property owners were willing to assist in said work. Referred to the Street Committee to report at next meeting.

On motion, the deed from Mrs. Annie T. Reed and husband for certain property for the widening and extension of Cleveland Street was accepted and ordered placed of record.

The City Attorney presented a proposed form of contract with P. M. Saroggin and L. A. Tucker for use of certain land as a roadway during the interference with traffic on Grant Street, and same was approved and the Mayor and Recorder authorized to execute same on behalf of the City.

Moved by Councilman Cotton, and duly seconded, that the lamp posts heretofore placed between corners, and which have not been paid for by the property owners, be removed and sold. Carried.

On motion, the Council then proceeded to the election, by ballot, of a Mayor, to fill the vacancy caused by the death of Mayor Ziesing. On the first ballot, the vote was as follows: Geo. W. Cruson, 1; W. W. Kimmel, 1; D. Cormier, 4. Mr. Cormier having received the votes of a majority of all members of the Council, was thereupon declared duly elected.

The matter of drainage across Grant Street, opposite the Reed property, was discussed, and referred to the Street Committee, with power to act.
