

City Council Chamber, Lebanon, Pa, Sept 15/12

Council called to order by Mayor Conner, all members of the council present. Minutes of previous meeting read and approved.

Street Com. pres. Wm Taylor, asked further time in which to make report of drainage across Grant Street.

A committee consisting of Wm Craunson, Ralston, and J. John, appointed to determine benefits and damage incident to the widening of Cab St, reported and asked for instructions before proceeding further.

Motion by Mr. Hatcher, and duly seconded, that the Com. be discharged. Carried.

Motion by Dr. Amos, which was duly seconded, that action in the widening of Cab St. be postponed indefinitely. Carried.

Street Sup. Mr. Green reported that some action should be taken by the Council as to the culvert on Grant St. near the Reed property; also as to the improvement of the wagon bridge that spans the ditch on Grove St. ^{As reported by the improvement of the road from the railroad bridge.} On motion these matters were referred to the Street Com. with power to act.

Marshall Bishop reported that the sidewalk in front of the Theatre is low in the middle and that the water, for this reason, does not flow into the gutter. This matter was also referred to the Street Com.

A representative of the Warren Construction Co. asked that the Council take some action as to the paving of Grant St, and Second & Third St. between Grant and Sherman. On motion of Mr. Blackburn, and duly seconded, the matter was laid on the table indefinitely.

Post Master Kirkpatrick reported the question of securing free mail delivery for Lebanon had been presented to the proper authorities, and that the Council and citizens must conform to the request.
