CITY COUNCIL CHAMBER, NOVEMBER 3, 1914.

Council met, and Mayor Cormier being absent, Councilman Amos was elected Mayor pro tem. Roll call showed the following Councilmen present: Blackburn, W. G. Amos, E. E. Taylor, B. L. Cotton, W. O. McClain.

Moved by Cotton and seconded by Taylor that the reading of the minutes of the previous meeting be omitted. Motion carried.

Moved by Blackburn and seconded by Cotton that on account of its being a legal holiday that the Council adjourn until Wednesday night, Nov. 4, 1914, at 8 o'clock. Motion carried, and Council stood adjourned.

CITY COUNCIL CHAMBER, LEBANON, OREGON, NOVEMBER 4, 1914.

Council met in regular adjourned session, with Mayor Cormier in the chair. Roll call showed the following Councilmen present:

Blackburn, W. G. Amos, B. L. Cotton, W. O. McClain, J. S. Northorp. Recorder Elkins being absent, Councilman Blackburn was selected to act as Recorder. Minutes of the meeting of October 20, were read and approved as read, also the minutes of the meeting of November 3 were approved.

No reports of standing committees. The report of special committee on street signs and house numbers was read by City Engineer McArthur. Moved by Northorp to accept the report, seconded by Amos. Motion carried. Moved by Amos and seconded by McClain that the committee be authorized to award the contract for furnishing the street signs, and that the committee have full power to act in all matters pertaining to street signs and house numbers until the completion of the work.

Report of City officers: City Engineer McArthur reported on the condition of Grant Street; that sawdust has been placed on same from the Eastern City limits up to Hiatt Street. Also, that about 300 yards of rock from P. M. Scroggin's plant has been placed on South Main Street; will soon begin getting rock from Mr. Larson's plant to complete the work.

Marshal Bishop reported that the old building on Second Street has been cleaned out, also that the goat yard has been cleaned up. Councilman Amos reported the goat yard sanitary and free from unpleasant odor.

Councilman Blackburn asked about the joining of the concrete pavement to the bitulithic at the corner of Grant & Park Sts. City Engineer explained that the space between the two is to be filled with an asphaltic mixture.

A petition for new sidewalk, from property owners in Wassom's Addition, North West Lebanon, was read. Mr. Amos moved this be referred to the Street Committee for further investigation. Second by Mr. Blackburn; motion carried.

A communication from Dr. Laird was read with regard to building a concrete walk along his property, asking to be allowed to wait

until spring to build same. No action was taken.

A resolution regarding the building of sidewalks was read, and new walks were ordered. A correction was made to the resolution in the description of the walk in front of the Baptist Church. Mr. Blackburn moved that resolution be accepted and placed on file. Second by Mr. Cotton; motion carried.

A resolution to amend the City Charter to permit the City to build its own sewers, was read. Councilman Cotton moved to adopt the resolution. Second by Mr. McClain; motion carried.

New business: City Engineer McArthur reported on the cost of building Mr. Hardman's sewer. Two blocks of sewer, City Engineer's estimate, \$426.20. Mr. Cotton as chairman of the sewer committee, reported favorably for Mr. Hardman. Councilmen Northorp & Amos opposed. No action taken.

City Engineer asked if he should charge the engineering work on Grant Street to the City or the abutting property. Motion by Cotton that it be charged to the property, seconded by Amos. Carried.

Councilman Amos spoke of having an ordinance providing for concrete walks on all new streets. Mr. Northorp moved to refer same to Ordinance Committee. Second, Mr. McClain. Motion carried. Councilman Amos spoke of building curbs, filling parkings and having a weed ordinance. Mr. Bishop spoke in favor of such an ordinance, and Mr. Cotton suggested that the trimming of trees be also included. Mr. Northorp moved to refer the matter to the Ordinance Committee. Second by Councilman McClain. Motion carried.

Mayor Cormier appointed Councilmen Northorp & Amos to serve with himself as members of the Budget Committee.

Councilmen Blackburn & Amos spoke favorably in the matter of meat and milk inspection. No action taken.

Councilman Amos moved the bills be allowed. Second by Mr. Northorp. Motion carried.

Councilman Blackburn spoke unfavorably in regard to discounting salary warrants. Mr. Northorp suggested that the salary of the officers be raised to make up for the discount. Councilman Amos inquired if the City Attorney is in communication with the Bonding Co., and spoke of issuing bonds in small amounts. Mr. Blackburn also spoke in favor of same.

Mr. Arnold was present and inquired about Franklin Street. Mr. Cotton said that owing to sickness of the City Attorney, the matter is delayed.

City Engineer McArthur inquired about the old minutes of Council meetings, wanting same to trace records of streets. Mayor Cormier directed Marshal Bishop to look up the first book, which is missing.

Councilman Amos moved to adjourn, seconded by Mr. Blackburn. Motion carried and the Council adjourned.

Motion carried.

Mr. Blackburn made a motion that Mr. Kuhn's license be not renewed. Certain accusations were made against Mr. Kuhn, who was called before the Council and heard in his own defense. The motion was lost.

The matter of licensing plumbers was discussed and upon motion referred to the Health & Police Com.

RESOLUTION

Regarding the Widening and Extension of Franklin Street.

WHEREAS, Franklin Street, in the City of Lebanon, Oregon, as at present established is only twenty (20) feet wide from the center of Elmore Street, South to the terminus of said Franklin Street; and,

WHEREAS, the Common Council of said City deems it expedient and for the best interests of said City, that said Franklin Street be laid out and widened to the width of fifty (50) feet, from the center line of said Elmore Street, South to the present terminus of said Franklin Street, and that it be further extended, ~~and laid out and opened,~~ fifty (50) feet in width, from its present Southern terminus, South to an intersection with the County Road at the City Limits; therefore,

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, OREGON:

That the City Engineer of said City be, and he is hereby directed and authorized to make a survey of said part of Franklin Street above mentioned, and of the above mentioned extension of the same, laying out the same to a width of fifty (50) feet for the entire length thereof from the center line of Elmore Street, South to the City Limits, and marking the boundaries thereof; and, further, to make a plat of the same and a written report containing a full and complete description of such street and change, and of the boundaries thereof, and of the portions of each lot and tract of land to be appropriated therefor, and to file said plat and report with the City Recorder within thirty (30) days from the date of this resolution.

Adopted by unanimous vote of the Council, and approved by the Mayor, this 17th day of November, 1914.

RESOLUTION NO. 22

Introduced by Councilman B. Cotton

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, OREGON THAT THERE IS HEREBY SUBMITTED TO THE LEGAL ELECTORS of the City of Lebanon, Oregon, for their approval or rejection, at the general City election to be held Monday, December 7, 1914, the following proposed act for a Charter amendment:

An act to amend the Charter of the City of Lebanon, Oregon, by adding thereto a section to be known as Section 220 A.

Whenever the Council shall deem it expedient that any sewer construction, extension or repair work shall be done by the City without the intervention of a contractor, it may in lieu of the proceedings specified in Sections 214 ~~to~~ 220, both inclusive, of this Charter proceed in the same manner as provided by Sections 207 ~~to~~ 213 of this Charter, both inclusive, in case of construction of, and assessment for street improvement where no contractor is employed.

Provided, however, that when neither the whole nor any part of such work is to be assessed against the property specially benefited, the Council may proceed with the same without giving notice.

Passed by the Council this 4th day of November, 1914.
