

The absence of the Recorder Councilman Blackburn acted as such. Roll call showed all members present. Minute of meeting of Dec. 15th read and approved. Finance Com. reported on its examination of the accounts of the City Engineer, Mr. Arthur, as to sewer construction work on Grand St., that they found said accounts correct as per the City Engineer's written report which was filed Dec. 15 1914, and that the accounts were in good order, and the Com. recommended that the same be approved. On motion the report of the Com. was approved, and adopted and the said written report of the City Engineer to be spread upon the minutes of the meeting, same being as follows:

Mr. Blackburn reported that the Plumbing Com. had held an examination of plumbers and had passed two applicants, and conditionally passed one other.

City Engineer Mr. Arthur reported on the matter of street signs and house numbering, stating that signs were about ready to be put up; also that the special com. recommended that on account of the very small cost of the house numbers (1 $\frac{3}{4}$ ¢ each) and the total cost being about 28⁰⁰ it would be cheaper for the City to pay for same than to attempt to collect of individuals. On motion the report and recommendation of the Com. was adopted.

City Engineer's report on widening and extension of Grand St. was read, and on motion same was accepted and the City Attorney was directed to prepare the proper ordinance embodying same.

Mr. Arthur presented his annual report which was placed on file.

D. 1001. Street Sup. Mr. Green read his annual report and on motion it was accepted and

placed on file.

Motion by Councilman Amos that the sum of \$554.3 left in the City Engineer's hands from the Sewer Fund be applied on the expenses of street signs. Motion carried.

On motion of Councilman Northrop \$300.00 of the Police Fund was transferred to the Interest Paying Fund.

Matter of the proper denominations of bonds was discussed. Motion by Councilman Cotton that the rates for the sale of Grant St Improvement Bonds be the same for both issues. Motion carried.

Gentlemen:

I submit the following report, togetherwith the canceled checks and other receipts, on the funds placed in my hands for sewer construction purposes for the year 1914.

I had on hand as a balance from last year,	- - \$	3.68
and received from the City Treasurer a total of,	- -	1904.37
I have also received from special sources,	- - - -	135.24
and from the sale of old sewer pipe,	- - - -	<u>24.66</u>
Making a total amount received,	- - - -	\$2067.95
There is a balance on hand of,	- - - -	<u>15.73</u>
Which leaves as balance expended,	- - - -	\$2049.22

Of this amount expended \$1713.90 is accounted for by pay rolls, the receipted originals of which I submit for your examination. The remainder is accounted for by freight bills and other minor accounts, receipts for which are filed, herewith, with the one exception of \$19.25 paid to Mr. Ed. Buchanan for wood delivered to the Electric Light Plant. I have no receipt for this amount other than the canceled check, No. 701, to which you are referred.
