

City Council Chamber,

Lebanon Oregon, Oct. 5, 1915

The common council met in regular session in the City Hall, with the mayor and all councilmen, except Councilman Ingram, being present, the city marshal and city attorney were also present. In the absence of City recorder W. A. Elkins, N. M. Newport was appointed recorder pro-tem.

Minutes of the last regular meeting were read and approved as read.

The street superintendent reported bridge work done during the last month to the amount of \$71.21 and street crossings to the amount of \$29.15 and that the work of North Main street was completed at a total cost of \$164.42, and for rock crushed and left in storage for repair work to the amount and cost of \$33.75.

On motion of councilman Amos the city marshal was directed to procure a suitable stove for the council chambers and a broom or dust sweeper for the same.

A committee was present from the Lebanon W. T. C. U. and submitted a proposition to the council to turn over the public library of the Union to the city. On Motion of Councilman Wallace the matter was laid on the table until the next regular meeting of the council. It was further moved and carried that the Mayor call a mass meeting of the adult citizens of the city to discuss the matter of the city taking over the library so as to get an expressing of the sentiment of the people of the subject; the meeting to be held prior to the next meeting of the council.

It was moved and carried that the Marshall construct macadam cross walks cross Main Street at the crossing on the new Macadam on North Main street in place of the old wooden crossings.

The City attorney was instructed to look into the matter of the lien for side walk against the property of Geo. W. Stimpson on south

side of Block 5 in Nassons Addition. to Lebanon.  
Resolution No. 17 for 1915, Declaring the Extension, widening and opening of Ast street from present terminus to Walnut street was read and passed by unanimous vote taken by aye and nay vote.

3rd day of August, 1915, and in which said ordinance the report of the said viewers was embodied in full, and the said report was by the said council duly approved and ratified in all things and the assessments of benefits and damages approved and confirmed by the Council, and the time for appeal from said assessments and awards has expired and no appeal whatever has been taken therefrom, or filed therein, and the said Council has heretofore declared and ordered that all such damages where in excess of the benefits shall be paid out of the general funds of the said city, and warrants for the several amounts so found to be due have been drawn and have been delivered and accepted and money is in the hands of the City treasurer applicable to the payment of all such warrants:-

NOW THEREFORE,

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, OREGON.

That the said Ash Street be, and the same is hereby declared to be and is opened, extended and widened as mentioned and described in the preamble of this resolution and in the said ordinance, and the land herein described be and the same is appropriated for that purpose and use.

And Be It Further resolved, That the City Recorder of the City of Lebanon, Oregon, cause to be filed for record in the office of the recorder of Conveyances of Linn County, Oregon, within thirty days from the date hereof a copy of this resolution, together with an accurate plat of the parts of said street so opened, laid out and widened and extended, and the property so appropriated for public use.

The City attorney to instructed to look after the matter of the benefit assessment against the property of W. E. Hardin for the opening of Grave Street from Oak street to Elmore Street, now owned by David Wood.

The City attorney was also instructed to complete the matter of the foreclosure of the sale of the lien against the lot of Phil Ritter for the improvement of Sherman Street.

The treasurer and recorder were directed to proceed to collect all assessments delinquent for the improvement of Main, Grant and Sherman Streets, and that delinquency certificates be issued if the same is not paid, and the city attorney foreclose the same,

The bill of R. M. Goodrich for \$10.00, for 100 loads of gravel for the improvement of Wheeler street was laid over until next meeting after being discussed by the council.

On motion three members of the fire department were appointed to call on and ask the Lebanon Lumber Co. to pay the expenses of the fire at the saw mill on Sept 21, amounting to \$15.50 for the fireman and \$1.85 to recharge the chemical engine. The Mayor named as such committee C. C. Wright, E. L. Clerk and Lester Stacy.

RESOLUTION NO 17, FOR 1915.

RESOLUTION DECLARING THE WIDENING AND EXTENSION OF ASH STREET  
IN THE CITY OF LEBANON, IN LINN COUNTY?? OREGON.

WHEREAS, The the common Council of the City of Lebanon, Oregon, did by Ordinance No. 188, duly passed by the Council of said City on the 16th day of March, 1915 and duly approved by the Mayor of the said City on the 16th day of March, 1915, declare it was expedient and for the best interest of the said City to widen and extend Ash Street in the said City, to make the same 60 feet wide, and by making the side lines of said street on the east side of the Lebanon and Santiam Canal conform to the side lines thereof on the west side of said canal, and to appropriate the following lands therefor, to-wit:-

(1) Beginning at the Northeast corner of Lot 9 in Riverdale Addition to Lebanon, Oregon, and running thence South 57.67 feet to a point 2.33 feet North of the Southeast corner of said Lot 9; thence West 120 feet to the West line of said Lot 9; thence North 57.67 feet to the Northwest corner of said lot 9; thence East 120 feet to the point of beginning.

(2) Beginning at a point 72.33 feet South of the Northwest corner of Lot One (1) in Riverdale Addition to Lebanon, Oregon, and running thence South 60 feet to a point 5.17 feet North of the Southwest corner of said Lot 1; thence East 242 feet to the East line of said Lot 1; thence North 60 feet; thence West 242 feet to the place of beginning: And

WHEREAS, in pursuance of Resolution No. 12 for 1915, duly adopted and passed by the said Council on the 20th day of April, 1915, H. L. Gilson, Joseph Stewart and B. L. Cotton were duly appointed a board of viewers to assess the benefite and damages and to locate and establish the said street as provided in said Ordinance No. 188, And

WHEREAS, The said Viewers did on the 16th day of June 1915, file with the City Recorder of the City of Lebanon, Oregon, their report in writing, And

WHEREAS, the said Council did by Ordinance No. 201 duly passed by the said Council on the 3rd day of August, 1915, which said Ordinance was duly approved by the Mayor of the said City on the
