Lebenon, Oregon. October, 18th, 1917.

DibynGouncil met in the Council Chambers at 8 o'clock P.M. with Mayor J.L.Underwood in the chair. Roll Call showed all members of the council present, also City Atty., N.M. Newport and Marshal J.R. Green, City Recorder C.H. Witman being absent A.I. Crandall was chosen to record the minutes for the evening.

Minutes of the previous meeting read and the approval of same was

deferred to the next meeting.

Written report was read by City Atty. Newport relative to the drainage of the northwest portion of the City and more particularly Mary. St. a topographical map accompanied the written report, said survey and elavations as well as the said map being made by the County Surveyor for Linn County, Mr. C.H. Leonard. The recommendation of Engineer Leonard was, that drainage would be the most feasible along the right of way and parallel with the southern pacific R.R. and that a ditch would need to be dug for a probable distance of not over six hundred feet and that the cost would not be more than thirty five dollars. It was moved and carried that the report be accepted and placed on file and that the City Atty., be instructed to obtain necessary permits and proceed with the work of said drainage.

Report of the City Fire Chief, R.L.Gilson, was ready by Atty Newton

and was ordered placed on file.

Report of City Warshall Green, was that there was a erosswalk-sing asked for on Ash Street on the Jest side of Williams St, and one on the East side of Second St. across Wheeler St, also that know the drain tile at intersections of streets with Oak St. should be run the full width of the streets. On motion the Marshall was instructed to secure the necessary materials and make the improvements prayed for.

Petition was read from property owners living on, or owning property along Williams St. between Grant and Ash St., be improved, in the same manner as the streets were being improved in what is Known as the "Ash Street District") from Ash St, to Grant St. The City Atty., reported that a majority of the front footage, as petitione was in favor in the improvement asked for. It was moved and carried that the petition be granted as a continuation of the Ash St. District and that work be ordered to proceed at once.

Councilman D.A. Reeves reported that certain residents residing and Park St. desired to spread a coat of crushed rock along the center of the readway on said street between Ash and Sherman St. It was agreed

by motion that the said residents be granted such privileges.
