Council met in regular session

Mayor Byron Millpap presiding:

Present on roll call. Councilmen A J Brandel
B L Cotton, S O Wallace, and L A Tucker.

The report of the Superintendent of Streets,
as to the condition of various sidewalks
was read, and on motion was accepted
and ordered placed on file:

Resⁿ 17. for 1919, ordering, repairing and rebuilding of certain
specified sidewalks. was read, and on roll
call was adopted. all the members of the
Council, present voting yes:

Ordinance bill # 12. for 1919 Authorizing the
improvement of Park Street from Grant St
to Sherman Street, and from Vine Street to
Ash Street; and of Ash Street from Main
Street to Second Street; was read the first
time in full, and on roll call, all members
of the Council present voting yes, was read
the second time by title only:

The bill was read the third time in full, and
on the question, shall the bill pass. on the
roll being called, all members present voting
yes: the bill was declared passed

(There being no objection the Title of the Bill
was declared to be the Title of the Ordinance:

Ord bill # 13. for 1919 Declaring the Gasoline fumes and odors
from the cleaning plant of The Green Clothing Co
to be a nuisance, was read the first time in
full, and on roll call, all the members present
voting yes, was read the second time by title
