

Lebanon Ore Dec 6th 1921

Council met in regular session.

Mayor Byron Willard presiding
Councilmen all present.

Minutes of previous regular meeting of Nov 15th
and of special meeting of Nov 25th read and
approved

The committee on Streets and Public property
reported that ^{the} manager of the Lebanon Mutual
Telephone Co. would not allow lights placed
on the Telephone poles in the alleys on either
side of Main Street. The matter of lights in
the alleys was referred back to committee.
The Superintendent of Streets reported that Foot
Bridge on Williams Street had been put back
in good condition, by day labor, as no bids
for doing the work by contract, could be secured.
On motion of Dr Kimmel, seconded by D C Southard
the Mayor was authorized to appoint a com-
mittee of Fire Property Owners, to recommend a
fire limit for a proposed new Fire Limit.

Ordinance:

Ordinance bill # 14 for 1921. to amend ^{Sec 81 of} Ordinance # 276
bill # 14 passed by the Council on the 29th day of June 1921
Or # 280 establishing a new Fire Limit, was read the
third time in full, and on the question shall

bill was declared passed.

There being no objection, the title of the bill was
declared to be the title of the Ordinance.

Ash Street, was read and referred to the
committee on Streets and Public Property.

The matter of License for Drays, was
referred to the committee on Licenses.

The matter of Temporary night watch was
left to the committee on Health and Police.
