

Lebanon Or Dec 16th 1924

Council met in regular session with all members of the Council present Mayor Thad Sterling presiding. Minutes of previous meeting, read and approved as read.

The City Attorney reported that the case of Miss Nancy Washburn vs. City of Lebanon had been set for trial in the January term of District Court, and suggested that provision be made for fees for witnesses that will be needed by the City.

The ways and means committee reported that tentative bids for proposed pavement of North and South Main Street had been received: \$1.85 per yard for Bitulitic, and \$2.10 per yard for Concrete; and also a bid of \$1.80 per yard for resurfacing E. Grant St. with Bitulitic top.

Resolution # 11 for 1924. Instructing the Recorder to cancel lien against Lots # 2-7 and 8 in Riverside addition to Lebanon Levied on account of Widening of East Ash Street, was read, and on roll call, was adopted, all members of the Council voting yes. Ord. Call # 17 for 1924, a bill for an Ordinance to fix the Salary of the Treasurer of the City of Lebanon at \$2600.00 per year, was read the first time in full. The roll was called, and there being no objection the bill was read the second time by title only; on the question shall the bill be read the third time now; The roll was called and there being no objection the bill was read the third time in full.

On the question shall the bill pass, the roll was called, and the vote resulted as follows:

Resolution No 11 for 1924.

A resolution cancelling the assessment against lots No. 2-7-8 in Riverdale Addition to Lebanon, Linn County, Oregon, which assessment was levied against said lots for the ~~XXXXXXXXXXXX~~ opening of East Ash Street.

Whereas an assessment was on the 24th day of Aug 1915 duly levied against lots 2, 7 and 8 in Riverdale addition to the City of Lebanon, Oregon, for the proportionate cost of opening ~~and~~ ~~improving~~ East Ash Street within the City of Lebanon, and

Whereas L.E. Prickett, the owner of said lots and the person liable for the payment of said Assessment did on the 16th day of August, 1922, pay to the then City Attorney the full amount of said assessment then due thereon, to-wit \$65.00, and took the receipt of said City Attorney therefor, and whereas, said sum not having been turned over to the City, the said lien on said lots was never cancelled.
