MINUTES

Lane Transit District EmX Steering Committee

Pursuant to notice given to *The Register-Guard* for publication on November 2, 2007, a meeting of the Lane Transit District EmX Steering Committee was held at 5:30 p.m. on Tuesday, November 6, 2007, at the Lane Transit District Board Room, 3500 East 17th Avenue, Eugene, Oregon.

I. CALL TO ORDER

Mr. Gaydos called the meeting of the EmX (BRT) Steering Committee to order.

II. ROLL CALL

Mr. Gaydos called the roll.

III. CHAIR'S COMMENTS

Mr. Gaydos observed there had been a significant amount of EmX activity, with two groups involved in examining transportation problem solutions in West Eugene, including an EmX corridor extension. He stated that the Federal Transit Administration had approved funding for a pilot project for a vehicle guidance system. The project RFP is anticipated to be released at the end of November.

IV. MINUTES

Mr. Egan moved to approve the minutes of September 4, 2007, as submitted. Mr. Sorenson provided the second. The motion passed unanimously.

V. PUBLIC COMMENT

There was no one wishing to speak.

VI. PIONEER PARKWAY EmX STATUS

Facility Services Manager Charlie Simmons reported on the November 1, 2007, meeting of the Pioneer Parkway Corridor Committee, which focused on a discussion of design issues and safety factors. Mr. Simmons stated that staff would contact property owners and tenants along International Way to begin conversations about the impact on their property. He anticipated submitting 30-percent drawings to the City on November 21 for their review, and he added that a meeting with the Springfield City Council was scheduled for January 28, 2008. Mr. Simmons told the group that the 30-percent drawings would illustrate the exact location of lanes. He stated that the corridor committee would be given an update on the discussions with the City prior to the City Council meeting.

Ms. Wylie asked if staff have considered any alternatives to Gateway Street, such as traveling behind Gateway Mall. Mr. Simmons stated that planning staff have looked at alternate routes, but they did not serve residential development on the east side of Gateway Street. He added that this also was a consideration for station placement.

In response to a question from Ms. Fitch, Mr. Simmons stated that LTD would work with City staff in the short-term to determine whether a bus lane or queue jumper was the best solution at the Beltline/Gateway intersection.

VII. WEST EUGENE EmX EXTENSION STATUS

Mr. Schwetz recommended appointing Micah Sardell as the Whiteaker neighborhood representative on the West Eugene EmX Corridor Committee.

Ms. Fitch moved to appoint Micah Sardell to the West Eugene EmX Corridor Committee. Mr. Sorensen provided the second. The motion passed unanimously.

Mr. Schwetz reviewed the agenda packet materials, including the proposed Purpose and Need Statement, proposed Goals and Objectives, preliminary process, and timeline. Mr. Schwetz pointed out the public comments received to date. Mr. Schwetz anticipated the scoping process

would conclude in February 2008, and a draft Environmental Impact Statement (EIS) would be issued in early 2009, with a final statement in 2010. Mr. Schwetz stated that service in the corridor was projected to begin in 2014 or 2015.

Mr. Schwetz used a series of aerial photographs to illustrate the potential West 11th Avenue corridor and the varying characteristics along the route. Mr. Schwetz noted that there were a number of environmental concerns—both natural and built—that would warrant consideration and analysis. Mr. Schwetz stated the Scoping process was a decision-making process that would result in identification of proposed alignments for further study. He stated that the environmental study and alternatives analysis considered three elements of alternatives: modal alternatives, alignment alternatives, and link alternatives; these elements could be mixed and matched during the analysis process. Mr. Schwetz stated that, along with the build alternatives, there also were transportation system management (TSM) alternative (scaled down EmX service), and a no-build alternative.

Mr. Schwetz stated that a set of screening criteria would be developed based on the Purpose and Need Statement and Goals and Objectives; the criteria would be used as the basis for recommending alternatives for further study. Mr. Schwetz stated that the next steps included developing staff recommendations based on public and agency input during the scoping comment period, and presenting recommendations to the EmX Steering Committee and the LTD Board of Directors.

Mr. Egan noted that some comments favored a 6th Avenue/7th Avenue corridor. He asked if there were other options for reaching West Eugene. Mr. Schwetz stated that there were few other viable routes.

In response to a question from Mr. Sorenson, Mr. Schwetz told the group that an EIS was required for the West Eugene corridor, but not for the two previous corridors, because of the level of likely environmental impact and the contentiousness of the project.

Mr. Sorenson asked if dividing the project into segments would avoid an EIS. Mr. Schwetz stated that some segments might not require an EIS, but the westernmost segments would.

Mr. Sorenson asked if there had been a decision to focus on any particular alternative, such as the alignment recommended by the West Eugene Collaborative (WEC). Mr. Schwetz replied that the public process generated advice from many interests and perspectives within the community; he stated that all of the input would be considered when alternatives were identified for further study.

Mr. Sorenson stated he was advocating for Lane County to contribute \$40,000 to the WEC.

Mr. Egan asked why the corridor did not use West 11th Avenue between Jefferson and Chambers Streets. Mr. Schwetz stated that LTD's objective was to obtain two lanes of exclusive right-of-way wherever possible; the stretch of West 11th Avenue between Jefferson and

Chambers Streets was not feasible because of the trees against the curb, parking on both sides of the street, and other impediments.

Mr. Egan asked if the extent to which dedicated lanes should drive the process had been considered. Mr. Schwetz replied that the Environmental Impact Statement would evaluate many factors and tradeoffs for getting the best performance from the corridor.

Mr. Egan recommended including that stretch of West 11th Avenue as an alternative. He noted that the consensus recommendations from the October 25, 2007, meeting of the WEC were based on less than the full group.

Mr. Schwetz introduced Mary Archer, LTD's new development planner.

VIII. OTHER BUSINESS

Mr. Gaydos determined there was no other business to discuss.

IX. NEXT MEETING

The next meeting was scheduled for December 4, 2007.

X. ADJOURNMENT

Mr. Gaydos adjourned the meeting at 6:35 p.m.

ACTION REQUESTED: Provide Draft Final Purpose and Need Statement Recommendations for the WEEE Project to LTD Board of Directors.

BACKGROUND: LTD Staff and consultants revised the proposed Purpose and Need Statement for the WEEE Project based on comments received from the public and partner agencies during the Scoping Comment Period (October 5, 2007 to November 6, 2007) and advice received from the WEEE Corridor Committee meetings held on October 25, October 30, and November 8, 2007.

Project Proceeding Through Scoping Phase:

LTD and the Federal Transit Administration (FTA) initiated the process for the development of an Environmental Impact Statement (EIS) for the project on September 27, 2007. The first phase of that process is called Scoping. The primary objectives of Scoping are to establish a purpose and need for the project and assemble the range of alternative alignments for the project. The Purpose and Need Statement for the project is used to develop a set of criteria that will be used to evaluate the range of alternatives selected. The alternatives will be carried into the Alternatives Analysis/Draft Environmental Impact Statement phase of the project.

The Development Process of the WEEE Project Purpose and Need Statement:

The federal environmental process requires the development of a project Purpose and Need Statement. This document is a summary of the reasons for the project. It serves as the foundation for the development of criteria that will be used to evaluate the range of alternatives taken into the Alternatives Analysis/Draft Environmental Impact Statement phase of the project. Based on the initial proposed Purpose and Need Statement, comments were collected during Scoping and categorized by scoping topics (Purpose and Need, Goal and Objectives, Alternatives, Issues and Concerns, Air Quality, Noise, and about twenty other topics). Additional comments were received at meetings held with the City of Eugene, the West Eugene Collaborative, neighborhood groups, and various service organizations. Overall, approximately 1000 comments were collected. In order to refine the development process of the project Purpose and Need Statement, LTD staff made documentation of the advice from the WEEE Corridor Committee members provided during a review of the comments specific to the proposed Purpose and Need and the Goal and Objectives.

Recommended Draft Final Purpose and Need Statement:

The attached recommended Draft Final Purpose and Need Statement (which includes the Goal and Objectives) reflects the feedback from the WEEE Corridor Committee and the comments received on the proposed Purpose and Need and Goal and Objective Statement.

Public Involvement and Agency Coordination Conducted for Scoping:

As part of the Scoping phase, a significant public involvement and agency coordination process was conducted. This effort focused on introducing the public and public agencies to the project and getting feedback on the four main products of the Scoping phase:

1. The Proposed Draft Purpose and Need Statement
2. The Proposed Draft Goal and Objectives
3. The Proposed Range of Alternative Alignments for Further Study
4. The Scope of Analysis

On September 24, FTA and LTD issued a Notice of Intent to publish an Environmental Impact Statement for the WEEE Project and initiated the project's Scoping Phase. As a part of Scoping, LTD issued and invited public and agency comment on its proposed Purpose and Need and Range of Alternatives to be studied in the Draft Environmental Impact Statement (EIS). During the 30-day comment period, LTD staff made presentations on Scoping products to various interest groups, including the West Eugene Collaborative, neighborhood groups, and service organizations. Meetings of the Corridor Committee and EmX Steering Committee also were held during this period.

Scoping Process Decision Making:

With conclusion of the public comment period, the EmX Steering Committee will be considering the public comment received and advice from the West Eugene Corridor Committee in the development of a recommendation to the Board on the Scoping products. Board action to adopt the Purpose and Need statement and Goal and Objectives will be requested at the December 19 Board meeting. Consideration of the Range of Alternative Alignments for Further Study and the Scope of Analysis will be requested at the Board's February 13 meeting.

Next Steps and Overall Project Schedule:

The Scoping process will be followed by an Alternatives Analysis and preparation of a Draft Environmental Impact Statement (EIS). These efforts will include opportunities for public and agency input. This will lead to the selection of a locally preferred alternative (LPA). A final EIS will be prepared based on the LPA. Each of these tasks includes an opportunity for public and agency comment. FTA will then issue a Record of Decision, which will allow the project to proceed to final design and construction.

A flow chart with timeline for these tasks is included in the enclosed attachment. It is expected that the Alternatives Analysis and preparation of a Draft EIS would be completed by the end of 2008. A preferred alternative would be selected in Spring 2009. The final EIS would be prepared and submitted to FTA for review in early 2010.
