CALL TO ORDER

The Meeting was called to order at 7:00 A.M. by Chairman Mike Courtney.

APPROVAL OF MINUTES

Rinehart moved, seconded by Prouty, to approve the March 21, 1984 meeting minutes as submitted. Motion passed unanimously. Yes - Cushing, Hall, Snow, Prouty, Rinehart. Absent - Zukin.

CITY COUNCIL MINUTES OF APRIL 2, 1984

City Council minutes reflecting council action on the March, 1984 Traffic Safety Commission proceedings were submitted for information only with no action necessary.

Staff explained that the recommendation to barricade East 18th Street above Dry Hollow Road had been denied by Council since further investigation indicated that one property owner would have been denied access to his residence.

ELECTION OF OFFICERS

Cushing moved, seconded to Snow, to appoint Kurt Corey as Secretary for the 1984-85 business year which begins May 1, 1984. During discussion, Prouty indicated his feeling that the duties could possibly be delegated to a Commission member. Following discussion, the motion carried 4-1. Yes - Cushing, Hall, Snow, Rinehart. Prouty moved, seconded by Rinehart, to appoint Don Hall as Vice-Chairman. Motion passed unanimously. Yes - Cushing, Hall, Snow, Prouty, Rinehart. Absent - Zukin.

Snow moved, seconded by Cushing, to appoint Mike Courtney as Chairman. Motion passed unanimously. Yes - Cushing, Hall, Snow, Prouty, Rinehart. Absent - Zukin.

POSTPONED BUSINESS

Request for Stop Signs at East 11th Street and East 12th Street at Clark Street

The accident report requested by the Commission was submitted for review. The report disclosed no accidents in the near vicinity within the past year. Staff expressed the opinion that stop signs could be warranted since both East 11th Street and East 12th Street are through streets, but recommended postponing the installations until Clark Street is improved. Prouty moved, seconded by Rinehart, to deny the request for stop signs at this time. Motion carried unanimously. Yes - Cushing, Hall, Snow, Prouty, Rinehart. Absent - Zukin.

Request to Prohibit Bicycles on Sidewalks

The request to prohibit bicycles on sidewalks as presented by Cliff Preston at the March, 1984 regular meeting was reviewed by the Police Department with their findings being submitted for information. The Police report included portions of O.R.S. 487 relating to Motor Vehicle Laws of Oregon and stated the belief that "State Law addressed the problem adequately and a City Ordinance would be redundant". The Commission concurred with the report and no action was taken.
