CALL TO ORDER

The meeting was called to order at 7:05 a.m. by Don Hall, at the Recreation Cafe, 215 E 2nd Street, The Dalles, Oregon.

MINUTES

A motion was made by Mark Sullivan, and seconded by Scott Mengis, to approve the minutes of April 17, 1989. The motion carried unanimously.

OLD BUSINESS

Don Hall wanted to know what the Operations Department schedule is for painting City streets.

Don Hall pointed out that the Commission terms have expired for himself, Scott Mengis, and Frank Bonn. Kim said she would check on the procedure to renew these terms.

NEW BUSINESS

Don Hall wanted to thank all those involved in the First Street project for their efforts.

Several tree violations were mentioned by various Commission members. Kim will be responsible to notify the property owners.

A motion was made by Frank Bonn, and seconded by Mark Sullivan, that the Traffic Safety Commission recommend to City Council that they make Brewery Grade its #1 priority and finish the project and do something with the intersection of Brewery Grade and East 2nd Street. The motion carried unanimously. Some of the

discussion concerned the turning movements at the intersection, i.e., no right turn onto East 2nd Street for trucks on Brewery Grade, and no left turn from 2nd Street onto Brewery Grade.

ADJOURNMENT

A motion was made by Mark Sullivan, and seconded by Frank Bonn, to adjourn the meeting at 7:45 a.m. The motion carried unanimously.

AND WASHINGTON STREET IN THE DALLES, OREGON


Dear Jerry,

I have a suggestion for changing the traffic pattern at the intersection of East 10th and Washington Streets. This is the intersection on the east end of The Dalles High School.

My suggestion is to exchange the left turn lane and the safety island. I feel it would give better vision of the turning vehicle and a better vision for the vehicle turning west from Washington Street to move the left turn lane easterly. This would put the safety lane next to the right turning lane. The left turn lane would be in a line with the center line of East 10th Street giving a better view down East 10th to those headed west. Also vehicles headed west down East Tenth Street from Federal Street who wanted to turn south on Washington Street would have additional space to make the swing south. At present it is a little tight for school buses to make the turn south to park by the High School. I have attached two sketches; one showing the intersection as it is now and another sketch showing my suggested change.






