CALL TO ORDER

The meeting was called to order at 7:10 a.m. by Don Hall, at the Recreation Cafe, 215 E 2nd Street, The Dalles, Oregon.

ROLL CALL

Present: Don Hall, Cecelia Cushing, Maury Snow, Becky Ohmart, Frank Bonn and Mark Sullivan.

MINUTES - NOVEMBER 15, 1989

A motion was made by Cecelia Cushing, and seconded by Maury Snow to approve the minutes of November 15, 1989, as presented. The motion carried unanimously.

OLD BUSINESS

Review: One Way (westbound) Parking on 5th Street Between Washington and Union Streets: It was moved by Frank Bonn and seconded by Maury Snow to table this item until additional information is provided regarding this topic, i.e. number of existing spaces, number of proposed spaces, angle parking, etc. The motion carried unanimously.

Vision Problem at N.E. Corner of Jefferson Street and Scenic Drive: It was moved by Frank Bonn and seconded by Maury Snow to send a letter to the City Fire Department requesting them to investigate the vision problem created by trees and shrubbery (northeast corner), including whether the corner in question is public or private property and to direct the fire department to take action accordingly. Motion carried unanimously.

Stop Signs at N.W. Corner of 12th Street and Shearer Street, 12th Street and Roberts Street and the N.W. and S.E. corners of 12th

Street and "J" Street: It was moved by Frank Bonn and seconded by Maury Snow to approve the installation of stop signs at the northwest corner of 12th Street and Shearer Street, northwest corner of 12th Street and Roberts Street and the northwest and southeast corners of 12th Street and "J" Street. The motion carried unanimously.

NEW BUSINESS

Review and Recommendation Regarding Proposed Skate Board Ordinance: After review and discussion of the Commission, it was the general consensus of opinion to obtain information from school districts number 12 and 9 regarding their policies on the matter. This item was tabled pending further information.

MISCELLANEOUS BUSINESS

Safety Belt Initiative: It was moved by Frank Bonn and seconded by Maury Snow to request the City Council to formally endorse the Safety Belt Initiative and to send a letter of support to the Oregon Lifebelt Committee. The motion carried unanimously.

ADJOURNMENT

A motion was made by Cecelia Cushing and seconded by Becky Ohmart to adjourn this meeting. The motion carried unanimously. The meeting was adjourned at 8:40 a.m.
