A mistake was noted in the January minutes. Under commission present Mike Kilkenny, Chuck Covert and Donna Lawrence were listed twice. Chuck Covert made a motion to approve the corrected minutes. Mike Kilkenny seconded the motion and the motion passed unanimously.

PUBLIC COMMENT/AUDIENCE PARTICIPATION/PRESENTATIONS:

Tim McGlothlin gave a discussion on relocation of the Yard Sale sign. The new location will be on a parking lot on the corner of 10th & Trevitt. Dale McCabe and Tim met at the site and made sure the vision clearance triangle was adequate. Tim met with Dawn Marie Hert in the Planning Office to make sure Planning issues were properly addressed. Tim also contacted Meadow Outdoor Signs to ensure their sign was not visually obscured.

Discussion within the TSC group occurred regarding the location and direction the sign will be facing north into the parking lot with the back of the sign facing towards 10th & Trevitt. Fred Davis made a motion to support the sign location. Donna Lawrence seconded the motion and the motion passed unanimously.

OLD BUSINESS:

1) Tree Trimming

The Transportation Division has not had a chance to trim the trees on Court Street, near 6th Street. They are on the top of the list to be trimmed.

2) Request for ADA Parking Space near 4th & Washington

Bill Barrier met with Deb Klaviter and she is working towards a solution.

NEW BUSINESS:

1) Tour Buses Driving down Jefferson Street from Scenic Drive

Donna expressed her concerns regarding the tour buses in the area using Jefferson Street, off of Scenic Drive, to get into the downtown area. Discussion was held regarding the steep incline and sharp curve halfway between Scenic Drive and 14th Street. Donna will talk with the City Clerk, Julie Krueger, about notifying the tour bus drivers of alternate routes.

2) Root in Road Causing a Driving Hazard

John Nelson said there is a root causing a bump in the road near the parking strip on Liberty near 6th Street. Bill will have his crew look at repairing it.


3) Upcoming Project on West 3rd Place
