**OLD BUSINESS:**

1) 10<sup>th</sup> & I Visibility Issue

Donna Lawrence explained the request for additional stop signs. Discussion was held regarding the elevation change at the stop sign. The City has many areas around town that drivers need to stop, pull forward slowly, then proceed with caution. No changes suggested at this time.

2) Request for 4-Way Stop

Chris Harrell said he received a thank you call from the citizen who had originally requested 4 stop signs at the 10<sup>th</sup> & Thompson intersection. Caller appreciated the extra attention the police have given to the area.

**NEW BUSINESS:**

A) Welcome New Member

Cindy Keever welcomed the newest Traffic Safety Commissions member, Larry Fairclo.

B) ADA request for 207 W 3<sup>rd</sup> Street

Dale McCabe received a request for an ADA parking space near 207 W 3<sup>rd</sup> Street. Discussion regarding where the closest ADA parking space are in relation to this address. Donna made a motion to recommend installing an ADA parking space, which would include painting the curb blue and painting a blue and white handicap stencil on the ground closest to the drive approach. Fred Davis seconded the motion and the motion passed unanimously.

C) Speed Reduction on East 2<sup>nd</sup> Street

Dale received a request from an employee at Bryant Pipe and Supply at 3012 E. 2<sup>nd</sup>, to reduce the speed limit on E 2<sup>nd</sup> Street to 25mph from approximately the overpass to the stop sign near Big Jim's Drive In. Jeff Kienlen will look at the history of accidents in that area and will gather some speed records and share the information at the February meeting. Further discussion to follow.

D) Blue Zone Group

Dale told members there is a Blue Zone Group Community Kick Off gathering at the Civic Auditorium @ 5:30p on January 19, 2018. The whole community is invited to attend.

E) West 2<sup>nd</sup> Street Utility Improvement Project


Dale said the West 2<sup>nd</sup> Street Project between Webber and Hostetler has started and is moving forward as planned. Completion projected by the end of June.


