## TRAFFIC SAFETY COMMISSION MEETING Of September 16, 2020 7:00a

### ZOOM MEETING

COMMISSION PRESENT: Frank Pyles, Larry Fairclo, Michael Holloran, Mike Kilkenny, and Russ Brown

**ABSENT MEMBERS:** Brent Bybee and Fred Davis

**STAFF PRESENT:** Cindy Keever – Administrative Secretary and Jeff Kienlen – City Police

PUBLIC PRESENT: Dan Richardson and Ben Wring

**APPROVAL OF MINUTES**: Mike Kilkenny made a motion to approve the August minutes. Michael Holloran seconded the motion and the motion passed unanimously.

### **PUBLIC COMMENT:**

Dan Richardson and Ben Wring joined our Zoom meeting and explained their concerns regarding the speed which traffic travels on Columbia View Heights near E Knoll Drive & Summit Ridge Drive. They asked if there were any traffic calming measures that could be taken to slow traffic thru the residential area. Russ Brown uggested talking to the Police Department and having a policemen stationed up there as much as possible.

Possibly talk to the Veteran's Home and have them talk to their employees about speeding thru the neighborhood while going to and leaving work. Are rumble strips a possibility? City staff will need to check into the possibility. Jeff Kienlen suggested a photo radar unit in the area (like on Dry Hollow). Michael Holloran praised the idea too. Members asked if city staff could check on prices for a photo radar system. Possible a portable one that could be set up at different locations? Cost for that? Could the radar sign on Dry Hollow be moved to Columbia View Heights?

Officer Kienlen suggested reducing the speeds from 35 to 25 mph, making the whole area a consistent 25 mph zone. The question was asked if the Google donation of the Rapid Flashing Beacon lights would be useful in that area? Something to research.

If cost could be researched and shared there is a possibility of a private donation being made to pay for the signage and/or photo radar system. Officer Kienlen suggested the City look at grants to pay for the equipment. Discussion will be continued at the October meeting.

#### **OLD BUSINESS:**

A) District #21 Bus Loading/Unloading Zone on 10<sup>th</sup> Street

Russ Brown reported city staff and Michael Holloran met with Lisa Kaseberg on site and a discussion was held regarding keeping the loading zone as it currently is being used and adding a crossing guard at the nearest crosswalk in the afternoon to help visibility. More discussion was suggested for the October meeting.
