TOPIC: Pavement Preservation Projects Continue, June 14 to June 16, 2021

The week of June 14, 2021, City crews and contractors will continue work on several pavement preservation projects. **These chip seal projects will require short duration road closures between 7:00 a.m. and 5:00 p.m. at each location on the date the work is scheduled to take place. Detours will be in place during work hours.**

CHIP SEAL - Is the application of a special protective wearing surface to an existing pavement. A thin layer of liquid asphalt is sprayed down in front of the chip spreader by a distributor. A dump truck full of chips (crushed rock) locks onto a chip spreader which is pulled backwards. The chips spread over the liquid asphalt are then compacted by rollers.

Chip seal projects may require a total lane closure for a day.

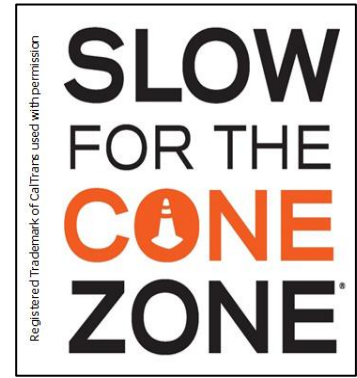
Equipment is slow moving and must cover the same area multiple times. Once the crew has left the work area, the rock is left on the road surface for seven to ten days so that vehicle traffic can continue to lock the rock into the liquid asphalt. Excess chips are then removed by sweepers to be reused on the next chip seal project.
