

RESOLUTION NO. P.C. 363-96  
APPROVING SITE PLAN REVIEW 231-96 OF  
G.H. MCCULLOCH (REPRESENTING KERR MCGEE) TO  
BUILD A POLE BUILDING WITH CORRUGATED SIDING  
ON A COMMON CONCRETE SLAB WITH EQUIPMENT  
INSTALLED IN BUILDING FOR BUSINESS OPERATION.

**I. RECITALS:**

A. The Planning Commission of the City of The Dalles has, October 3, 1996, conducted a public hearing to consider the above request for property located at 100 Tie Plant Road, and described as Township 1 North, Range 13 East, Section 2, Tax Lot(s) 600.

B. A staff report was presented, stating the findings of fact, conclusions of law, and a staff recommendation.

C. Staff Report of Site Plan Review 231-96 and the minutes of the October 3, 1996, Planning Commission meeting upon approval, provide the basis for this resolution and are herein attached by reference.

**II. RESOLUTION:**

Now, therefore, be it FOUND, DETERMINED, and RESOLVED by the Planning Commission of the City of The Dalles as follows:

A. In all respects as set forth in Recitals, Part "I" of this resolution.

B. Site Plan Review 231-96 is hereby approved with the following conditions:

1. All requirements of the State Building Codes Agency, DEQ, The Dalles Public Works Department must be met prior to issuance of building permit.

**III. APPEALS, COMPLIANCE, AND PENALTIES**

A. Any party of record may appeal a decision of the Planning Commission to the City Council for review. Appeals must be made according to Section 36 of the Zoning Ordinance, and must be filed with City Clerk within ten (10) days of the date of resolution.

B. Failure to exercise this approval within the time limits set either by resolution or by ordinance will invalidate this permit.

- C. All conditions of approval must be met within the time limits set by this resolution or by ordinance. Failure to meet any condition will prompt enforcement proceedings that can result in: 1) permit revocation; 2) fines of up to \$2,500.00 per day for the violation period and/or imprisonment in the County jail for a term not to exceed one (1) year.

The Secretary of the Commission shall (a) certify to the adoption of the Resolution; (b) transmit a copy of the Resolution along with a stamped approved/denied site plan or plat to the applicant.


