

RESOLUTION NO. P.C PC 306-94  
APPROVING SITE PLAN REVIEW 199-94 OF ST. VINCENT DE PAUL FOR A  
"COMMUNITY FACILITY" OVERLAY ZONE TO USE THE EXISTING BUILDINGS  
TO SERVE COMMUNITY MEALS AND ESTABLISH A THRIFT STORE

**I. RECITALS:**

- A.** The Planning Commission of the City of The Dalles has, on this day, conducted a public hearing to consider the above request for use of property located at 1501 West 2nd Street and described as 2N-13E-33D:300 and zoned "M-2" Heavy Industrial.
- B.** A staff report was presented, stating the findings of fact, conclusions of law, and a staff recommendation.
- C.** Staff Report Site Plan Review No. 199-94 and the minutes of the November 17, 1994, Planning Commission meeting upon approval, provide the basis for this resolution and are herein attached by reference.

**II. RESOLUTION:**

Now, therefore, be it FOUND, DETERMINED, and RESOLVED by the Planning Commission of the City of The Dalles as follows:

- A.** In all respects as set forth in Recitals, Part "I" of this resolution.
- B.** Site Plan Review No. 199-94 is hereby approved with the following conditions:
1. Applicant shall provide adequate bicycle parking near the main entrance.
  2. All requirements of the State Building Codes Office, the Fire Marshall, and the City Utilities Department shall be met prior to occupancy.
  3. Any future lighting shall be arranged to direct light away from adjoining properties.
  4. Any future signs will require a permit be obtained from the Planning Department prior to installation.

**III. APPEALS, COMPLIANCE, AND PENALTIES**


**A.** Any party of record may appeal a decision of the Planning Commission to the City Council for review. Appeals must be made according to Section 36 of the Zoning Ordinance, and must be filed with City Clerk with in ten (10) days of the date of resolution.

**B.** Failure to exercise this approval within the time limits set either by resolution or by ordinance will invalidate this permit.

**C.** All conditions of approval must be met within the time limits set by this resolution or by ordinance. Failure to meet any condition will prompt enforcement proceedings that can result in: 1) permit revocation; 2) fines of up to \$2,500 per day for the violation period and/or imprisonment in the County jail for a term not to exceed one (1) year.

The Secretary of the Commission shall (a) certify to the adoption of the Resolution; (b) transmit a copy of the Resolution along with a stamped approved/denied site plan or plat to the applicant.
