

RESOLUTION NO. P.C. 237-93
APPROVING SPR 162-93 OF WASCO COUNTY TO BUILD AN 8,600
SQUARE FOOT CHILDREN'S CENTER TO HOUSE THE HEADSTART AND EARLY
INTERVENTION PROGRAMS

I. RECITALS:

- A. The Planning Commission of the City of The Dalles has, on this day, conducted a public hearing to consider the above request for use of property located 1721 West 10th Street, described as Township 2 North, Range 13 East, Section 33C, tax lot 3900.
- B. A staff report was presented, stating the findings of fact, conclusions of law, and a staff recommendation.
- C. Staff Report SPR 162-93 and the minutes of March 18, 1993 upon approval, provide the basis for this resolution and are herein attached by reference.

II. RESOLUTION:

Now, therefore, be it FOUND, DETERMINED, and RESOLVED by the Planning Commission of the City of The Dalles as follows:

- A. In all respects as set forth in Recitals, Part "I" of this resolution.
- B. Site Plan Review 162-93 is hereby approved with the following conditions:
 - 1. If the grant application is successful and the project moves forward, a detailed site plan be submitted to the Planning Department for staff review to ensure all standards are met prior to issuance of a building permit.
 - 2. Trash and solid waste material shall be contained on the site in properly identified facilities and disposed of at regular intervals to insure sanitary conditions.
 - 3. All proposed required or existing lighting should be directed away from adjoining property to insure compliance with outdoor lighting standards.
 - 4. All signs must meet the sign ordinance requirements and be permitted through the Planning Department.


III. APPEALS, COMPLIANCE, AND PENALTIES

- A. Any party of record may appeal a decision of the Planning Commission to the City Council for review. Appeals must be made according to Section 36 of the Zoning Ordinance, and must be filed with City Clerk with in ten (10) days of the date of resolution.

- B. Failure to exercise this approval within the time limits set either by resolution or by ordinance will invalidate this permit.
- C. All conditions of approval must be met within the time limits set by this resolution or by ordinance. Failure to meet any condition will prompt enforcement proceedings that can result in: 1) permit revocation; 2) fines of up to \$2,500 per day for the violation period and/or imprisonment in the County jail for a term not to exceed one (1) year.

The Secretary of the Commission shall (a) certify to the adoption of the Resolution; (b) forthwith transmit a copy of said Resolution to City Council of the City of The Dalles; (c) transmit a copy of the Resolution along with a stamped approved/denied site plan or plat to the applicant.


