

**RESOLUTION NO. P.C. 179-91**

**RECOMMENDING THAT CITY COUNCIL APPROVE COMPREHENSIVE  
PLAN AMENDMENT NO. 13-91 FROM URBAN RESIDENTIAL TO  
"GENERAL COMMERCIAL" & ZONE CHANGE NO. 45-91 FROM  
"R-3" MULTI-FAMILY RESIDENTIAL TO "CB" CENTRAL BUSINESS  
DISTRICT FOR RESTAURANT AT 515 LIBERTY.**

**I. RECITALS:**

- A. The Planning Commission of the City of The Dalles has, on this day, conducted a public hearing to consider the above request for use of property described as:  
  
515 Liberty Street, described as 1N-13E-SBC, tax lot 6000
- B. A staff report was presented, stating the findings of fact, conclusions of law, and a staff recommendation.
- C. Staff Report No. CPA 13-91 AND ZNC 45-91 and the minutes of July 25, 1991, upon approval, provide the basis for this resolution and are herein attached by reference.

**II. RESOLUTION: Now, therefore, be it FOUND, DETERMINED, and RESOLVED by the Planning Commission of the City of The Dalles as follows:**

- A. In all respects as set forth in Recitals, Part "I" of this resolution,
- B. Comprehensive Plan Amendment 13-91 and Zone Change 45-91 of Jack Bryant are hereby recommended for approval and referred to The Dalles City Council for final hearing and determination.


**III. APPEALS, COMPLIANCE, AND PENALTIES**

- A. Any party of record may appeal a decision of the Planning Commission to the City Council for review. Appeals must be made according to Section 36 of the Zoning Ordinance, and must be filed with City Clerk with in ten (10) days of the date of resolution.
- B. Failure to exercise this approval within the time limits set either by resolution or by ordinance will invalidate this permit.
- C. All conditions of approval must be met within the time limits set by this resolution or by ordinance. Failure to meet any condition will prompt enforcement proceedings

that can result in: 1) permit revocation; 2) fines of up to \$2,500 per day for the violation period and/or imprisonment in the County jail for a term not to exceed one (1) year.

The Secretary of the Commission shall (a) certify to the adoption of the Resolution; (b) forthwith transmit a copy of said Resolution to City Council of the City of The Dalles; (c) transmit a copy of the Resolution along with a stamped approved/denied site plan or plat to the applicant.
