Landmarks Commission Application #152-16; Route 30 Bottles & Brews; Request: To refurbish the front façade. Project includes a new awning, decorative stone work, and new signage. The property is located at 317 E. 2<sup>nd</sup> Street, The Dalles, Oregon and is further described as 1N 13E 3 BD 2500. Property is zoned "CBC" – Central Business Commercial, in The Dalles Commercial Historic District.
