RESOLUTION NO. 09-066

A RESOLUTION ADOPTING A SUPPLEMENTAL BUDGET FOR FISCAL YEAR 2009/2010, MAKING APPROPRIATIONS AND AUTHORIZING EXPENDITURES FROM AND WITHIN THE COLUMBIA GATEWAY URBAN RENEWAL AGENCY FUND (200) AND DEBT SERVICE FUND (210).

WHEREAS, the City Council, at their regular meeting on September 14, 2009, adopted Resolution No. 09-028 authorizing issuance of the 2009 FFCO bond and the execution of an agreement for a note accepting a loan of up to \$11,500,000 of those funds to the Columbia Gateway Urban Renewal Agency to refund the 2002 Bonds and to provide for additional Urban Renewal Projects; and

WHEREAS, the loan of the bond proceeds to the Urban Renewal Agency Funds 200 and 210 require a supplemental budget to allocate and expend those funds; and

WHEREAS, an additional amount of the Urban Renewal Property taxes to be received by the Agency in FY09/10 is needed by the Debt Service Fund (210) in order to pay to the City the Urban Renewal share of the first payment due on the 2009 FFCO Bonds on June 1, 2009; and

WHEREAS, diverting those property taxes from the Agency Fund (200) to the Debt Service Fund (210) will cause a reduction in revenues in the Agency Fund; and

WHEREAS, a Public Hearing was held regarding this supplemental budget, which exceeds ten percent (10%) of the receiving funds, before the Urban Renewal Board of Directors on October 12, 2009, in accordance with Oregon Budget Law;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE COLUMBIA GATEWAY URBAN RENEWAL AGENCY AS FOLLOWS:

Section 1. The Urban Renewal Board of Directors hereby adopts the following Supplemental Budget for FY09/10, increasing revenues and making appropriations as shown below.
