REGULAR AGENDA ITEMS

Item 4(a): <u>YMCA Grant Acceptance for Youth Summer Camp Funding</u>

The Oregon Alliance of YMCAs has received funds from the State of Oregon to distribute to eligible summer camp programs in order to reduce the impacts of COVID-19 effect on the availability of summer care options for youth 0-13 years old. The Parks and Recreation Department has been allocated \$9,000 to be used by June 30, 2021 for camp activities that will take place in July and August. The grant funds are reimbursable and can be used toward staffing expenses, supplies, or maintenance items that otherwise would have been unfunded due to cancelations of programs.

The Parks and Recreation Department will use the funds to purchase needed supply items in order to offer at least two weeks of summer day camp in July/August that will be centered around youth athletic and activity engagement using the Astoria Aquatic Center as the site for camp operations. Spaces will be limited due to anticipated staffing challenges and compliance with COVID-19 guidelines. The Parks Department expects to begin advertising for the day camp in late May/early June with registration closing by mid-June. At the time of this memorandum's development, the City Attorney's review of the agreement was in process and will be updated at the meeting.

It is recommended that the City Council accept the grant agreement from the Oregon Alliance of YMCAs in the amount of \$9,000 to support summer day camp resources offered by the Parks and Recreation Department for youth ages 0-13 years.
