MOTION Executive (Non-public) Session Pursuant to ORS 192.660(1)(a): Mr. Kleger moved that the Board meet in Executive Session pursuant to ORS 192.660(1)(a), to convore sider the employment of a public officer. The motion was seconded and passed by unanimous vote.
