INTRODUCTORY REMARKS BY BOARD PRESIDENT: Mr. Kohnen informed the Board that approval was needed on a corporate resolution form authorizing establishment of a savings account at Equitable Savings and Loan, and signing authority for Kenneth H. Kohnen, Ted J. Langton, and Phyllis P. Loobey. He said that the primary purpose of the savings account is for the temporary placing of funds at a higher interest rate than is now being earned. The savings account terms are \$100,000 minimum on a 30-day certificate at 18.5% interest.
