I have a couple of issues to address regarding the ongoing process of committee appointments.

I noticed that during the extended application period, applications for CAC are not being accepted, presumably because all the pending vacancies were filled by the motion to approve the recommendations at the Dec. 10th Council meeting. Since at least part of the reason for the extended application period was to provide an opportunity for "late" applicants to be reconsidered, it's interesting to note that the existing Budget Committee applications were suspended, but CAC's were not, although there were late applicants for both. By creating a new deadline for Budget applicants you're essentially saying that the original deadline was irrelevant.

My second issue is that a major argument for accepting Mr. Staffenson's late application, and not Mr. Canfield's the year before, was that 2018 had a sufficient number of applicants for all committees to fill all the pending vacancies. I matched the complete list of applicants for 2018 with the final list of appointments, and there in fact had <u>not</u> been enough applicants to fill every slot. In the end, every slot was filled, but it required placing three applicants in Positions for which they had not applied. As it turns out, the comparison between the two years was a false distinction.

A more noteworthy comparison between '18 and '19 was that there were twice as many incumbents applying in '18 as in '19. That would mainly account for why there were more applicants in '18 vs '19, yet there were still not enough applicants overall to fill all the vacancies.
