Councilor Lauer stated in honor of Memorial Day he would like to read about a classmate of his that died serving our country. He read an excerpt from the Estacada Fire Department. "Jeremy Loveless became a volunteer firefighter with Estacada Rural Fire Department in February of 2004. He quickly decided the fire service was his calling and that he would work towards obtaining his paramedic license. After his first year with Estacada Fire, Jeremy joined the United States Army as a way to pay for paramedic school and provide for his family. Jeremy deployed to Iraq with the Army Second Battalion First Infantry Regiment. On May 29, 2006 Corp. Loveless was riding in a medically equipped Stryker vehicle during combat operations in Iraq. Normally the medics are safely tucked away in the patient treatment area of the Stryker. Jeremy volunteered for the turret to people watch and throw candy to the children. In this situation, Jeremy volunteered for the turret position as it allowed an additional crew member to be deployed outside of the vehicle during an operation. As a Stryker vehicle came under small arms fire, Corp. Loveless was killed. Jeremy's Stryker buddies would say of him that they were glad to have him in their Stryker vehicle. Jeremy leaves behind a wife, daughter and family."

Councilor Moon informed the Council that on August 21st and 28th there will be Movies in the Park by Imagination Station. He would love for the Council to make popcorn or do something to serve the community and say hi.

CHAPTER 34 AN ACT HB 4120

Relating to transient lodging taxes; creating new provisions; amending ORS 320.300, 320.305, 320.325 and 320.350; and prescribing an effective date.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 320.300 is amended to read: 320.300. As used in ORS 320.300 to 320.350:

(6) "Tourism" means economic activity resulting from tourists.

(7) "Tourism promotion" means any of the fol lowing activities:

(a) Advertising, publicizing or distributing information for the purpose of attracting and welcoming tourists;

(b) Conducting strategic planning and research necessary to stimulate future tourism development;

(c) Operating tourism promotion agencies; and (d) Marketing special events and festivals designed to attract tourists.

(10) "Tourist" means a person who, for business, pleasure, recreation or participation in events related to the arts, heritage or culture, travels from the community in which that person is a resident to a different community that is separate, distinct from and unrelated to the person's community of residence, and that trip:(a) Requires the person to travel more than 50 miles from the community of residence; or(b) Includes an overnight stay.

SECTION 3. ORS 320.350 is amended to read: 320.350.

(5) Subsections (1) and (2) of this section do not apply to a new or increased local transient lodging tax if all of the net revenue from the new or increased tax, following reductions attributed to collection reimbursement charges, is used consistently with subsection (6) of this section to:

(a) Fund tourism promotion or tourism-related facilities;

(c) Finance or refinance the debt of tourism related facilities and pay reasonable administrative costs incurred in financing or refinancing that debt, provided that:


(A) The net revenue may be used for administrative costs only if the unit of local government provides a collection reimbursement charge; and

(B) Upon retirement of the debt, the unit of local government reduces the tax by the amount by which the tax was increased to finance or refinance the debt.

(6) At least 70 percent of net revenue from a new or increased local transient lodging tax shall be used for the purposes described in subsection (5)(a) or (c) of this section. No more than 30 percent of net revenue from a new or increased local transient lodging tax may be used for the purpose described in subsection (5)(b) of this section.

SECTION 9. This 2018 Act takes effect on the later of the 91st day after the date on which the 2018 regular session of the Seventy-ninth Legislative Assembly adjourns sine die or July 1, 2018.



This comment is marginally related to the old City Hall bond measure elsewhere on the agenda, but I think this is the more appropriate time slot. The last odd-year local ballot measure was the fuel tax proposal, which only drew 30% voter turnout. While it did pass, non-voters may have been thinking that it wouldn't affect them anyway if they didn't purchase, or stopped purchasing, motor fuels at Troutdale fuel stations. I'd expect higher voter turnout regarding a property tax bond because that will affect every property owner, and potentially renters also, in the city.

If the Council and city staff are going to go to the trouble and expense of placing a measure on the November 2019 ballot, perhaps it would be worthwhile to add some Charter Amendment proposals while you're at it, which I believe would draw in even more voters. I still have over 600 signatures of Troutdale citizens who have called for a Charter Amendment to have plurality-at-large, or top-three, election of City Councilors. I suspect there is even more interest and support for a change after the 2018 election, in which the voters were shut-out of having a choice for two of the three Council Positions. We also now have two new Councilors who have not had an opportunity to weigh-in on the option. I also understand that quite a few signatures, but not enough, were collected to get a term limits measure on the ballot. There's also a need for clarification in some areas of the Charter.

Finally, I would like to remind presiding officers that agenda items beyond consent agenda are <u>all</u> subject to public comment, not just those which call for a public hearing.



Between NE Arata Rd. and NE Oregon St.











NE 238th Drive // Alternate Routes










Bridge Construction SE Cochran Road



SE Cochran Rd. Bridge Construction // Location










