CALL TO ORDER

Chair Eric Gleason called the meeting to order at 4:02 P.M.

APPROVAL OF AGENDA

Clason moved that the agenda be approved as submitted. McNary seconded the motion. The motion was passed unanimously.

APPROVAL OF MINUTES

Gleason asked if there were any corrections to the minutes of April 28, 2004. Parker moved to approve the minutes as submitted and McNary seconded. The motion carried unanimously.

PUBLIC COMMENT

Earline Wasser, 1017 Pomona West #B, The Dalles, handed out information on a disinterment that will take place in the Pioneer Cemetery. The Commission and Staff discussed the rules that will need to be followed, including a public hearing. Hert said she would contact Sunne Preston and discuss the submittal of an HLC Application so a public hearing posting can be done as soon as possible.

DISCUSSION

- A. Historic Plaques- Hert updated the Commissioners on the plaque status. Hert said she would be applying for funding for fifteen plaques next year. She is hopeful the plaques can be completed before Historic The Dalles Days.
- B. Draft Cemetery Plan Hert copied and distributed the latest draft version. She asked the Commissioners to review it and contact her within the next week if they had any changes or suggestions. Earline Wasser will be surveying headstone locations and conditions. Sally

Donovan is prepared to present the maintenance plan before City Council. Staff and Commissioners discussed the cemetery inventory and also the placement of a storage shed.

COMMISSIONER/STAFF COMMENTS

Hert said she would try to attend the Preservation Conference in Portland on September 8th. Gleason asked Hert to try and get The Dalles on the "field trip" list. Clason said the timing is right. McNary said he might be interested in going with Hert on the 8th.

McNary asked what is the status of the Chamber Building. Hert said they are currently trying to get the necessary number of property owners to support their request for a street vacation. There is no expiration on the demolition permit for their historic building. Hert said the Chamber of Commerce would have to go through a review process with Historic Landmarks to get their new site approved.

McNary asked if someone could buy the Granada and gut it. Hert said that interior remodeling does not need review by the Historic Landmarks Commission. Staff and Commission members discussed various downtown historic buildings. Gleason recommended strengthening the Ordinance regarding demolition requirements. Hert said she would contact Poyser at SHPO and talk to him about it.

NEXT MEETING DATE

A special meeting may be required for the disinterment public hearing. The next regular meeting is scheduled for September 22, 2004.

ADJOURNMENT

McNary moved the meeting be adjourned and Parker seconded. The meeting was adjourned at 5:17 P.M.

CALL TO ORDER

Chair Eric Gleason called the meeting to order at 10:46 P.M.

APPROVAL OF AGENDA

Clason moved that the agenda be approved as submitted. Dundon seconded the motion. The motion was passed unanimously, Parker and McNary absent.

APPROVAL OF MINUTES

None available for approval.

PUBLIC COMMENT

None

PUBLIC HEARING

Historic Landmarks Commission Application #85-04 of Sunne J. Preston to disinter her Great Grandmother, Mary A. Porter, from the Pioneer Cemetery, remove the remains & have them cremated. The cremated remains and the headstone will be transported by family members and placed with her Great Grandfather Claudius Porter in the Calhoun Cemetery in Harrison County, Iowa.

Gleason asked if he needed to read the rules for conducting a public hearing being as there was no public in attendance and Durow said if the Commission consented the rules would not need to be read. Gleason asked if any Commissioners had ex-parte contact, bias, or conflict of interest and no one did.

Gleason declared the public hearing and Director Durow presented the Staff Report.

Durow stated that the Commission has no authority to decide "if" the disinterment takes place but rather "how" it will take place. Durow went on to inform the Commission that there is a family dispute regarding the disinterment, which is a civil matter between them. Durow asked if the Commissioners had any questions.

Gleason asked if the family would still own the plot if no body is buried there. Durow said there are no records to show ownership for the Pioneer Cemetery plots. However, it has always been the case that families buy and own the burial plots and headstone and he assumes that is the case here. The family would continue to own the plot.

Discussion: The Commissioners revised the proposed conditions of approval. Condition number seven was revised to read: "The applicant shall replace the headstone with a similar headstone of similar size and material at the family plot that contains the same information as the original headstone of Mary Porter plus the date she was disinterred and the place of re-interment, for historical purposes." Condition number eight was added and reads: "This approval is for the remains of Mary Porter only; any other person's remains must be left in place." Condition number four added "…only hand excavation will be permitted…" and … "The excavators will work in concert with the on-site archaeologist…"

Dundon asked if the newspaper would be involved when the disinterment takes place. Durow said he sees it as a private family matter.

The Commissioners would like City Attorney Parker to look into whatever legal means may be available to keep this type of activity from happening again.

Dundon moved to approve the revised conditions for the disinterment of Mary Porter and Clason seconded. The motion carried unanimously, Parker and McNary absent.

Clason moved to approve HLC 85-04 based upon findings of fact with conditions of approval as revised and Dundon seconded the motion. The motion carried unanimously, Parker and McNary absent.

RESOLUTION

Clason moved to adopt Resolution 81-04 with conditions of approval as revised and Dundon seconded. The motion carried unanimously, Parker and McNary absent.

NEXT MEETING DATE

The next regular meeting is scheduled for September 22, 2004.

ADJOURNMENT

The meeting was adjourned at 11:35 a.m.
