ORDINANCE BILL NO. 2 for 1949

ORDINANCE NO.

FOR AN ORDINANCE LICENSING PHOTOGRAPHERS, PROVIDING PENALTY FOR THE VIOLATION HEREOF, REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, AND DECLARING AN EMERGENCY.

The people of the City of Lebanon do ordain as follows:

The people of the City of Lebanon do ordain as follows: SECTION 1. That it shall be unlawful for any person, firm or corporation, to engage in the business of an itinerant, or resident studio photographer within the City of Lebanon without having first procured a license therefor, as hereinafter provided, from the City Recorder of the City of Lebanon.

SECTION 2. Photographers shall be defined as follows:

- (a) An itinerant photographer, as referred to herein, is defined to be a person, firm or corporation
 who solicits the taking, finishing, coloring, enlarging and sale of photographs for profit in the
 City of Lebanon, and who takes photographs but who
 has no studio or other place of business in the
 City of Lebanon for the taking and finishing of
 photographs and equipped therefor.
- (b) All persons, firms or corporations engaged in the business of soliciting, taking, finishing, and selling photographs who maintain a studio or other place of business equipped for takingland/or, enlarging, coloring and finishing of photographs within the City of Lebanon for six months or more in any one year and who in fact carry on the business of soliciting, taking, finishing, coloring, enlarging or selling photographs within the City of Lebanon for profit, shall be known as resident studio photographers.

SECTION 3.

The license fees for itinerant photographers as hereinabove defined shall be (\$15.00) a day or fraction thereof, and each person who solicites the taking, finishing, coloring, enlarging and sale of photographs for profit in the City of Lebanon and who take photographs therein but who has no studio or other place of business in the City of Lebanon for the taking and finishing

of photographs and equipped therefor, The license shall be paid by or on behalf of every person so engaged whether such person or persons be the owner of the business or employed by the owner.

SECTION 4.

The license fees for resident studio photographers shall be Twenty Dollars (\$20.00) per annum, or fraction thereof and an additional license fee of Fifteen Dollars (\$15.00) per annum or fraction thereof shall be charged for each solicitor or salesman employed by said resident studio photographer, the regular resident photographer's license fees to be dated from the filing the application therefor. All licenses issued under this ordinance shall expire on December 31st following the issuance thereof, and the fees and fractions of a year shall be prorated according to the portion of the year for which the license is granted but no license shall be granted less than the fee of Five Dollars (\$5.00). Licenses issued hereinunder shall not be transferable.

SECTION 5.

That any itinerant photographer, as herein defined, or any other person, firm or corporation, who may desire to qualify and be classified as a resident studio photographer, as herein defined, shall, upon making application for such a resident studio photographer's license, deposit with the City Recorder of the City of Lebanon the sum of Two Hundred Fifty Dollars (\$250.00) as a bond to guarantee his or its full and complete compliance with the provisions hereof; that, after having fully qualified as such a resident studio photographer, as herein defined, said deposit shall be returned to said applicant less the license fee of an amount which will be equal to that of a resident photographer from the date of the filing of the application. Provided that in case said applicant shall fail to qualify and be classified as a resident photographer, the total amount deposited as bond shall upon the expiration of six months from the date of filing the application be forfeited.

SECTION 6.

That any person, firm or corporation violating any of the terms of this ordinance shall, upon conviction, be fined in the sum of not less than Twenty-Five Dollars (\$25.00), nor more than Three Hundred Dollars (\$300.00) for each offense, and each day such person, firm or corporation engages

in said business in violation of this ordinance, shall be deemed a separate offense.

SECTION 7.

That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 8.

In the opinion of the Council, this ordinance is necessary for the immediate protection and preservation of the public health, safety, convenience and general welfare, and it is enacted for that purpose, and shall be in full force and effect from and after its passage and the date of its final publication.
