THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section (1) That the Mayor and the Recorder of the City of Lebanon be directed to accept a deed from Carl O. Sahleen and Helen M. Sahleen of the following described real property located in the City of Lebanon and donated to the City of Lebanon for street purposes, to-wit:

Beginning at the intersection of the South line of Elmore Street and the East line of Lot 11, said beginning point being on the East line of and South 15.00 feet from the Northeast corner of Lot 11 in Home Addition to the City of Lebanon, Linn County, Oregon; running thence southerly along the east line of said Lot 100.00 feet; thence westerly parallel to the north line of said Lot 20.00 feet; thence northerly parallel to the east line of said Lot 100.00 feet to the South line of Elmore Street; thence easterly along said street line 20.00 feet to the place of beginning.

ALS O, beginning at a 3/4" iron pipe on the East line of and South 115.00 feet from the Northeast corner of Lot 11 in Home Addition to the City of Lebanon, Linn County, Oregon; running thence southerly along the East line of said Lot 73.50 feet; thence westerly parallel to the north line of said Lot 20.00 feet; thence northerly parallel to the east line of said Lot 73.50 feet; thence easterly 20.00 feet to the place of beginning, being for street purposes.

and that they be directed to accept a deed from Lebanon, Oregon Congregation of Jehovah's Witnesses, Inc., of the following described real property located in the City of Lebanon and donated to the City of Lebanon for street purposes, to-wit:

Beginning 60 feet North and 30 feet East from the Northeast corner of Block 5, MOUNTAIN VIEW ADDITION to Lebanon; thence North 130 feet; thence East 30 feet; thence South 130 feet; thence West 30 feet to the place of beginning.

Section (2) That the Recorder of the City of Lebanon is hereby

directed to file the said deeds for record with the County Recorder of Linn County, State of Oregon.

Section (3) Whereas it is necessary for the peace, health and safety of the people of the city of Lebanon that such additional paving be done at the earliest possible date, an emergency is declared to exist and this Ordinance shall become effective immediately upon its passage by the Council and approval by the Mayor.
