The purpose of The Dalles Traffic Safety Commission is to Promote Public Awareness of Vehicle, Pedestrian and Bicycle Safety through Education, Review of Traffic Concerns and Recommending Solutions.

The Traffic Safety Commission is an advisory board only. Recommendations are forwarded to the Public Works Director who then forwards the recommendations to the City Manager for approval or denial

A monthly meeting is held at the City's Public Works office in the conference room on the 3rd Wednesday of each month at 7:00 a.m.

Appointments are made by the Mayor and terms are for 4 years and can be held for 2 consecutive terms (plus time served if filling a previous member's term).

Preference is given to qualified applicants who have experience or expertise related to traffic safety issues, but no specific requirements on living locations, education or experience, etc.

COMMITTEE VACANCIES:

The City of The Dalles has two vacancies:

Urban Renewal Budget committee, generally one or two evenings the first week of May. This open term ends June 30, 2020.

What is the Local Budget Law process?

Local budget law requires certain, specific actions as a local government prepares its budget.

- The budget officer prepares a proposed budget.
- The governing body appoints voters to the budget committee.
- The budget officer publishes notices of the budget committee's first meeting.
- The budget committee reviews the proposed budget, considers comments from the public, sets fiscal policy, and then approves the budget and tax levies.
- The budget officer publishes notice of budget hearing, including a summary of the budget ap proved by the budget committee.
- The governing body holds a hearing on the approved budget.
- The governing body adopts the budget, makes appropriations and imposes and categorizes property taxes.
- The governing certifies its property taxes to the county assessor.

During the fiscal year, when the local government is operating under the adopted budget, the governing body may change the adopted budget. Changes are necessary before additional money is spent or money is spent for a different purpose than as appropriated.

What is a budget?

A budget is a financial plan containing estimates of revenues and expenditures for one fiscal year or biennium.

When does a fiscal year or biennium start and end?

A fiscal year begins on July 1 and ends on the following June 30.

"April Showers, Bring May flowers.....and WEEDS"

With Spring comes vegetation growth....weeds, puncture vine (goat head) and blackberry bushes!

Just a reminder that City General Codes does not allow vegetation growth over 12 inches on properties; and enforces removal and disposal of puncture vine and control of blackberry bushes.

Also, with Spring comes the burning season (April 1– May 14) for vegetation as well. Be mindful that burning in burning barrels is **NOT** allowed within City limits and that all burning of vegetation requires a permit from Mid-Columbia Fire and Rescue and only during the burning seasons (April 1-May 14; and October 16 –December 1).



THINK BEFORE YOU FLUSH

Where Does The Dirty Water Go?

Anything that you flush in your toilet or pour down the drain flows into your home sewer pipes and into the City sewers. City crews maintain about 100 miles of pipe to carry sewage to the wastewater treatment plant. The wastewater is cleaned before it is discharged to the Columbia River.



The Toilet Is Not A Trash Can

Only two things should go down your toilet – human waste and toilet paper. If other items are flushed they can cause a clog and sewer backups in your home plumbing or in the City sewers. The most common items found by crews removing sewer clogs are cleaning wipes, paper towels, diapers, underwear and feminine sanitary supplies. Often these items are mixed with chunks of fats, oils and grease that go down the kitchen drain when washing dishes after cooking, baking or frying.

Sewage from all over the city flows to the wastewater treatment plant. Large sanitary sewage pumps keep wastewater moving into the treatment process. Items that have not caused clogs in the sewer pipes can cause expensive damage to the treatment plant intake pumps.

Freeze The Grease, Save The Drain

When fats, oils and grease are washed down your sink, they stick to the insides of sewer pipes. Over time, grease and oils can build up and clog the pipes. Home garbage disposals and hot water do not keep grease and oil from clogging plumbing systems.


3 Simple Ways to Avoid Kitchen Clogs

- 1. Cook with only the oil you need so there is very little left over.
- **2.** Wipe greasy pans and dishes with a paper towel and throw the dirty paper towel in the trash can.
- **3.** Pour fats, oils and grease into an empty food can, freeze it, then toss it into the trash can on garbage pick-up day.

How To Report A Sewage Overflow

Sewage is a public health hazard and can harm stream and river habitat. If you see sewage overflowing from a manhole or onto private property, please call right away.
