Many new discoveries at the Granada Theatre A Report from Charles Gomez

Jason Corey Appointed as Municipal Court Judge



The City of The Dalles is pleased to have Jason Corey serve as Municipal Court Judge.

Corey was appointed when Thomas Peachey retired earlier this year.

Corey has been an attorney with Dick, Dick and Corey in The Dalles since 1994.

Work on the Granada Theatre has finally begun in earnest. After two weeks of constant cleaning, four truckloads of trash and unwanted broken items have been removed from what many thought to be an already pretty clean Granada. That alone has already made a very noticeable difference and the Theatre has started to come alive once again. After the trash was removed the front portion of the theatre was given a thorough cleaning.

The theatre owners have meet with Dawn Hert, City staff for Historic Landmarks Commission and so far so good as to the exterior renovation plans. Presently power washer, sealer, plaster restorer, primer and painter have been hired and that work is scheduled to start in the next four weeks. With permission the old 1960s – 1970s flat metal awning has been removed. And that leads us to the first major discovery.

Underneath the supports of that awning were wonderful Art Deco Moorish Revival plaster details. The upper parts of these details were partially visible with the awning in place but still very hard to see. The tops of those details are now painted to match the walls almost hiding them from view but hidden away were several of their original colors. What was found was a deep red/brown almost a dark wine color. Stunning. Now under consideration is leaving the awning off entirely to feature and show off these details. While original color photos of the outside of the theatre have yet to be found, an original color plate of an Art Deco Moorish Revival building, built for the 1912 world's fair in San Francisco clearly shows its dome as copper. Copper and not the cheap aluminum/tar roof coating now on the domes. The domes will be coated again but this time with a copper based product out of Pennsylvania.

The other more whimsical discovery was found in the basement. Asked to come into the theatre and review the cooling and beverage tap system was the original company who installed it many years ago. The theatre was well aware of many old barrels of beer left behind but two of the kegs had never been and were still unopened. One from a brewery that no longer distributes in Oregon or just possibly The Dalles and the other is now completely out of business. Vintage beer!



The electrical company working in part at the Neon museum has also been hired to review, evaluate and update any issues with the electrical system. A plumbing company to do likewise is now also being sought. Windows were also discussed and the owners believe a more environmentally friendly and energy efficient window is called for today, in review are the Marvin windows already approved for and installed in several other downtown landmark buildings.

The presently installed main floor theatre seats are being donated to the restoration efforts at the Civic Auditorium for the balcony and 62 to the Neon Museum for their viewing theatre.

Painting is set to start in the Café portion of the theatre and only 1930s colors are being considered. The original floor tile installer for the Café floor has been found and will review repair issues with the new old stock spares found in the basement.

Marquee colors are still under the owners review. The original marquee was in place only seventeen years while the existing marquee has been there since 1948 and its colors are being reviewed from the early 1950's styles. And keep in mind that older marquees were always very very colorful. Just recall the many colors of neon found on old marquees. Almost any and every bright color.

The new theatre seats, proto types have arrived. Once the main sample has all size issues worked out it will be presented and placed on display as the theatre's new seats for the next 40 years.

While working in the café many river boat tourists stopped to see what all the construction commotion was and the owners offered impromptu tours to nearly 30 visitors from 5 different states from as far away as Iowa and Michigan.

Managing Vegetation and Fire Danger:

It's that time of the year in The Dalles where grasses grow quickly and quickly turn to fuel for fires.

City General Ordinance #99-1234: Vegetation growth over 12 inches is a violation on any commercial, public or private property and must be maintained or this could result in the imposition of fines and/or liens upon the property for the costs of removing the nuisance condition.

Information received from Mid-Columbia Fire and Rescue reiterates the importance of managing vegetation in our community:

The general rule for flame lengths with light fuels (grasses) is that the flame will be up to 4 times the height of the vegetation. So with 12 " grass, we would expect to see up to 4 foot flame lengths.

Flame length is an important fire behavior factor we must consider. Generally fires with flame lengths greater than 4 feet are too intense for direct attack on the head of a fire by persons using hand tools. Here is the NWCG guideline:

- 4' Fire can generally be attacked at the head or flanks by persons using hand tools. Fire hand lines should hold the fire.
- 4'-8' Fires are too intense for direct attack on the head by persons using hand tools. Fire hand lines cannot be relied on to hold fire.
- 8'-11' Fires may present serious control problems; torching out, crowning and spotting. Control efforts at the head will probably be ineffective.
- >11' Crowning, spotting and major fire runs are probable. Control efforts at the head of the fire are ineffective.

PUNCTURE VINE AKA GOATHEAD

Puncture vine is noxious vegetation in accordance with

City Ordinance No. 99-1234.



How do I get rid of them?

For small clusters of puncture vine, it's best to just dig them out. Where they are growing in the lawn, they can be pulled by hand. It is best to pull the vines while they are still small and before they've bloomed.

If the patch is too big to pull, and you are unable to burn, the final option is through applying an herbicide; several applications should be applied during the summer as new seedlings begin to develop.

The best solution to slowing down the spread of puncture vine is to prevent it from coming onto your property. This can be done by always checking your bicycle or vehicle tires, shoes and pet's feet after a walk through the neighborhood or a local park. Maintaining a thick and healthy lawn will also help discourage the growth of puncture vine. Puncture vine does not thrive well in irrigated areas.

New rules approved by the Oregon Legislature make it more convenient to participate in The Dalles' downtown Vertical Housing Zone

The City of The Dalles established a Vertical Housing Zone in 2014 with the State of Oregon to support the development of upstairs housing in the downtown core. The Vertical Housing Zone provides a tax exemption of 20% per floor, to a maximum of 80%, over a 10-year term for qualifying residential projects.

Senate Bill 310, signed by Governor Kate Brown on June 14, 2017, makes several substantial changes to the program. Originally, parties interested in taking advantage of the program would submit an application to the Oregon Housing and Community Services Department to be reviewed and managed. Under the new bill, the sponsoring entity, City or County, will review and manage all zone applications.

Another change under the bill requires entities considering new zone sponsorship to "consider the potential for displacement of households within a proposed vertical housing development before designating the zone." However, the City of The Dalles has already established a zone, so that provision doesn't apply here.

The City of The Dalles will be working to update local Vertical Housing Zone management policies before the bill takes effect.

Long Term Enterprise Zone Deadline Extended

Currently, the **Long Term Enterprise Zone abatement** deadline has been extended to December 31, 2017, to better align with the collection and analysis of data upon which the zones are based. The application eligibility for **Standard and Extended abatements** is due to expire on June 30, 2018. However, legislation is being considered that would allow The Dalles to qualify for continued abatement.

Enterprise Zones provide property tax abatements to promote economic development in economically depressed areas. Eligible businesses are those engaged in manufacturing, hotel/resort, call center, or ecommerce. Retail and some specific types of businesses such as health care or professional services are not eligible.

There are three types of agreements; Standard, Extended, and Long-Term Abatements.:

The Standard abatement lasts 3 years and requires a \$50,000 minimum investment, an increase in employment of 10% inside the zone, does not create a job loss within 30 miles, maintains 110% minimum average employment, a First Source Hiring Agreement, and annual reporting.

The Extended abatement is for 4 to 5 years and has the same requirements as the Standard abatement but also requires wages that are 150% of the County average and requires a financial payment based on the amount of tax abated.

The Long-Term Abatements are up to 15 years and are on negotiated terms. I


