

RESOLUTION NO. 2532

A RESOLUTION TO APPROVE AN AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF FAIRVIEW TO PROVIDE COURT SERVICES

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. The City of Fairview and the City have had a long history of cooperation in the improvement of services to the citizens and the business community; and
2. On January 12th, 2021, the City Council approved an intergovernmental agreement to provide court services to the City of Fairview for misdemeanor matters; and
3. Fairview wishes to enter into an amendment to that intergovernmental agreement for the provision of additional court services described in this agreement; and
4. Troutdale is agreeable to provide such additional services on the terms and conditions set forth herein; and
5. Parties have authority to enter into this intergovernmental agreement pursuant to the powers contained in their respective charters, and as identified in Oregon Revised Statutes, chapter 190, granting the ability for governmental entities to jointly exercise authorities through agreement, and
6. Parties more specifically have the authority under both ORS 221.355 and their home rule authority to reach an "Agreement Between Cities for Judicial Services".

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE

Section 1. Agrees that it should enter into an Amendment to the IGA with the City of Fairview to provide shared court services in the form attached to the Staff Report.

Section 2. Designates the City Manager or Finance Director (each a "City Official) or designee of the City Official, to act on behalf of the City, and without further action by the City Council. The City Official is hereby authorized, empowered and directed to sign the amendment to the IGA on behalf of the City, and any and all other required and necessary documents to implement the intent of the agreement.

Section 3. The City Official is hereby authorized to execute, acknowledge and deliver the amendment to the IGA in substantial conformity with Exhibit A of the Staff Report, including any other supporting and implementing documents, and to take any other action as may be advisable, convenient, necessary, or appropriate to give full force and effect to the terms and intent of the IGA, and the execution thereof by any such City Official shall be conclusive as to such determination.

Section 4. Further, consistent with the intent of the IGA, and the amendment, and in the best interest of the City, the City Official is authorized to determine, execute, acknowledge, and deliver any subsequent addendums, extensions, revisions,

modifications, or successor documents of the IGA, and the execution thereof by any such City Official shall be conclusive as to such determination.

Section 5. This Resolution shall take effect immediately upon adoption.
