EXHIBIT A

SE 12th Street

A tract of land in the NE 1/4 of Section 27, Township 8 North, Range 10 West, W.M. City of Warrenton, Clatsop County, Oregon, beginning at the Northeast corner of Lot 5, Block 85, Warrenton Park, Plat Records, Clatsop County, Oregon, said point being on the South right-of-way line of SE 12th Street, thence South 89 degrees 49'00" West, along said South right-of-way line, a distance of 198.97 feet; then North 00 degrees 06"17" East 35.00 feet to the centerline of said SE 12th Street; Then North 89 degrees 49'00" East, parallel to and 35 feet Northerly from the South right-of-way line of SE 12th Street, a distance of 198.80 feet; thence South 00 degrees11'00" East 35.00 feet to the Point of Beginning containing 6,961 square feet.

SE 12th Place

A tract of land in the NE 1/4 of section 27, Township 8 North, Range 10 West, W.M. City of Warrenton, Clatsop County, Oregon, Beginning at the Southeast corner of Lot 12, Block 85, Warrenton Park, Plat Records, Clatsop County, Oregon, said point being on the North right-of-way line of SE 12th Place, said street also being known as 19th Street, Thence South 89 degrees 49'00" West, along said North right-of-way line, a distance of 199.98 feet; Thence South 00degrees11'00" East 7.48 feet to a point on the North rightof-way line of Alternate Highway 101 (40.00 feet from the centerline therof); Thence Southeasterly, along said North right-of-way line of Alternate Highway 101 along the arc of a Spiral curve to the right, the chord of which bears South 80degrees55'20" East 103.37 feet; Thence Southeasterly, continuing along said North right-of-way line of Alternate Highway 101, along the arc of a non-tangent 994.90 foot radius curve to the right, through a central angle of 8degrees45'47" (chord bears South 79degrees45'11" East 152.01 feet) an arc distance of 152.16 feet to a point on the centerline of SE 12th Place; Thence South 89degrees49'00" West, parallel to and 35.00 feet Southerly of said North right-of-way line of SE 12th Place, a distance of 50.47 feet; Thence North 00degrees11'00" West 35.00 feet to the Point of Beginning containing 4,636 square feet.
