RESOLUTION NO. 96-061

A RESOLUTION ACCEPTING THE REPORT OF THE CITY ENGINEER, ANNOUNCING THE FORMATION OF A LOCAL IMPROVEMENT DISTRICT FOR EAST 16TH STREET SANITARY SEWER IMPROVEMENTS, 100 FEET WEST OF THOMPSON STREET TO SHEARER STREET

WHEREAS, the City Council has heretofore called for an engineer's report, announced its intention to improve, called for remonstrances and held a hearing to consider remonstrances and objections relating to the East 16th Street sanitary sewer improvements, 100 feet west of Thompson Street to Shearer Street; and

WHEREAS, the City Council held a hearing and considered the engineer's report and any remonstrances and objections thereto at its meeting on December 23, 1996, 5:30 p.m. Pacific Prevailing Time; and

WHEREAS, the City council has considered the report and objections thereto; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL AS FOLLOWS:

Section 1. Remonstrances. The Council finds that the period for receipt of remonstrances has expired. There are 10 property owners listed on the proposed assessment roll. The City Council finds the remonstrances received were insufficient to defeat the proposed improvement project.

Section 2. Acceptance of Engineer's Report. The Study and Report of the City Engineer, dated December 6, 1996, which includes Exhibits setting forth the approved method of assessment, a copy of which is attached hereto and made a part hereof by this reference, is hereby adopted and approved.



Section 3. <u>Creation of Improvement District</u>. A local improvement district comprised of the properties to be benefitted, which are identified in the Engineer's Report, is hereby created.

Section 4. <u>Intention to Proceed</u>. The City hereby announces its intention to proceed with the East 16th Street sanitary sewer improvements, 100 feet west of Thompson Street to Shearer Street. City staff is authorized to proceed with preparation of plans and specifications, and to call for bids to let out work on contract.

EAST 16TH STREET SANITARY SEWER

Councilmembers:

The following is a Preliminary Study and Report to provide the Assessment District, Basis for Assessment, and estimated costs to construct a sanitary sewer in East 16th Street, west of Thompson Street, lying in Blocks 12 and 13 of Thompson's Addition to the City of The Dalles.

DESCRIPTION OF THE PROJECT

The proposed sanitary sewer will connect into an existing 8" sanitary sewer at East 15th Street and Shearer Street. The City of The Dalles will pay for a portion of the sewer line from East 15th Street to East 16th Street, including two manholes. The Assessment District would then construct and pay for the cost of the sewer in Shearer Street and East 16th Street, from Shearer Street westerly 75 feet and easterly 510 feet east of Shearer street. Owners of the properties being served by the gravity sanitary sewer will be assessed the cost of this construction, as outlined on the District Boundary Map (Exhibit A).

ENGINEER'S ESTIMATE

The cost of this project is estimated at \$53,987.70. The estimated City cost is \$16,579.00, leaving the assessment cost at \$37,408.70. This cost will be paid by the owners of the adjacent property along Shearer Street and the northerly and southerly rights-of-way of East 16th Street being served by the proposed sanitary sewer. The total frontage to be assessed is 873.15 feet. This computes to an estimated cost of \$42.84338315 per front foot. Details of this estimate and the basis of assessment are provided in Exhibits B and C, attached.

ASSESSMENT DISTRICT

Those tracts fronting the northerly and southerly sides of East 16th Street, beginning at a point 100 feet west of the westerly right-of-way of Thompson Street and thence westerly 697

feet to the west line of Block 13, except for Tax Lot 500, 1N-13-11BA, and Tax Lots 1000, 1100, 1200, and 1300, 1N-13-11AB.

ASSESSMENT DISTRICT BOUNDARIES

The following is the external boundary of the property to be included within the Assessment District for the proposed project.

A strip of land 104.5 foot depth from the north right-of-way of East 16th street, from a line 67.15 feet west of the west line of Block 13 easterly 92.15 feet, then 109.0 feet depth easterly 159.4 feet. On the south side of East 16th Street, a strip of land varying from 234 foot depth to 85 foot depth from the west line of Block 13, east 697.0 feet.

This boundary includes the following tax lots on Wasco County Assessor's maps.

Tax Lots 600, 700, 800, and 900 of Map 1N-13-11BA


